40 MINUTES

The Committee confirmed the minutes of the meeting held on 19 December 2014 as a correct record and they were signed by the Chair.

41 DEVOLUTION DEAL - UPDATE

Councillor Neil Clarke, Rushcliffe Borough Council, provided the Committee with the following information:

- (a) a delegation from the D2N2 Local Enterprise Partnership attended Whitehall on 17 March to meet with Greg Clark, Minister for Cities, to discuss how the Nottingham, Nottinghamshire, Derby and Derbyshire councils can increase functions over jobs, skills and transport in the area;
- (b) the prospectus was well received as it is cross-political party and is a collaborative deal between the authorities;
- (c) Greg Clark said there needs to be greater emphasis on HS2 and the universities so this will be worked on;
- (d) it has been agreed that work by officers on the deal can continue during the pre-election period, with political involvement being reinstated after the election.

RESOLVED to thank all of those involved in the delegation for attending the meeting, and those involved in preparing for the Devolution Deal.

42 COMBINED AUTHORITY - PROGRESS UPDATE

Andrew Muter, Chief Executive of Newark and Sherwood District Council, provided the Committee with the following information:

- (a) the amendments to the governance review have been completed and the proposal has been submitted to the Department for Communities and Local Government (DCLG) for checking;
- (b) Derbyshire are also in the process of submitting their proposal for checking;
- (c) if the DCLG are happy with the proposals then they will be formally submitted next week.

RESOLVED to publish a press release, agreed with all authorities, when formal submission takes place.

43 SKILLS HUB

Allen Graham, Chief Executive of Rushcliffe Borough Council, provided the Committee with the following information:

- (a) there are currently two challenges – whether current skills are being maximised and identifying future skills and whether they can be met;

- (b) it is important to ensure that the 'skills chain' reflects the life cycle of childhood through to retirement to ensure that necessary skills are linked together;
- (c) pathways into work are wider than education through FE colleges and universities;
- (d) a number of 'hubs' have been established as mechanisms to help people access work. There is a need to rationalise the offer across the County to simplify the process;
- (e) since 2009/10 the take up and provision of apprenticeships has increased, but the number of 16-19 year olds accessing apprenticeships has remained static. A Commons Select Committee report (*Apprenticeships and traineeships for 16-19 year olds 4 March 2015*) indicates this could be due to schools currently being assessed on academic success and targets. There are currently no performance indicators in relation to how many young people are placed with a good quality employers or apprenticeships;
- (f) there may need to be a workshop for partners to come together to discuss skills in further detail.

The Committee made the following comments:

- (g) skills will be a focus for the Combined Authority;
- (h) skills need to match employment opportunities and it is important to promote sectors that contain small and medium sized enterprises to ensure their needs are met;
- (i) FE colleges need to provide courses which offer the skills to meet the demand of services;
- (j) there are many job vacancies, but a shortage of people with the necessary skills to fill them;
- (k) it could be beneficial to review fees for courses which address the skills shortage;
- (l) businesses also need to invest and be responsible for training and apprenticeships to help people gain necessary skills.

RESOLVED to develop a work plan to address the skills needs throughout the County.

44 EPC GOVERNANCE ISSUES

Glen O'Connell, Secretary to the Committee, introduced his report requesting that the Committee agree which members will perform the Chair and Vice-Chair roles for the forthcoming part year that the Committee will be in operation for, as the new N2 Combined Authority will replace the current Committee.

RESOLVED to agree the following roles for the forthcoming part year:

- (1) that Councillor Graham Chapman, Deputy Leader of Nottingham City Council, continue as Chair of the Committee;**
- (2) that Councillor Neil Clarke, Leader of Rushcliffe Borough Council, be appointed as Vice-Chair of the Committee.**

Reasons for decision

The Chair and Vice-Chair's terms of office come to an end in May 2015 so appointments to the roles need to be agreed for the part of the forthcoming year that the Committee is in operation for, as the roles will be brought to an end by the establishment of any N2 Combined Authority in December 2015.

Other options considered

No other options were considered as the Committee must agree its Chair and Vice-Chair for the forthcoming part year.

45 BROADBAND - CONTRACT 2 BIDDER RESPONSE

Matt Lockley, Economic Development Team Manager, Nottinghamshire County Council, introduced his report detailing the response from BT in relation to the Better Broadband for Nottinghamshire Programme proposal for contract 2 of the Superfast Extension Programme money, and highlighted the following points:

- (a) the recommendation in the report has been removed in light of the proposal received from BT. A revised recommendation will be discussed during the consideration of the exempt appendices;
- (b) BT submitted its proposal to the County Council on 13 February 2015. 24,737 premises in the City and County were eligible for contract 2, but the response from BT would provide a fibre broadband solution for 10,990 of these premises, some of which are in the City, which is inconsistent with the approach previously agreed by all partners for a focus on the areas of the County with the lowest coverage rates;
- (c) it was agreed that investment in contract 2 would be targeted at the Borough and District Council areas that do not achieve 95% coverage by the end of contract 1 – Bassetlaw, Newark and Sherwood and Rushcliffe. The invitation to tender reflected this prioritisation;
- (d) the BT submission doesn't respond sufficiently to the priorities as a significant proportion of the total homes passed (THP) (the standard performance measure) are in urban areas, particularly the City;
- (e) the County Council has been negotiating with BT to try and mitigate this as the percentage of THP with access to fibre broadband after contract 2 in the three priority areas is as follows:
 - Bassetlaw – 93%;

- Newark and Sherwood – 93%;
- Rushcliffe – 96%;

(f) the total coverage across the City and County will reach just over 97% once both contracts have been completed, which means that there will be approximately 13,750 premises without access to fibre broadband.

1 REASONS FOR RECOMMENDATIONS

- 1.1 To ensure that preparations for the implementation of the Combined Authority are progressed in a timely way and that the Economic Prosperity Committee can take appropriate decisions about its governance, resources, policy development and delivery arrangements.

2 BACKGROUND (INCLUDING OUTCOMES OF CONSULTATION)

- 2.1 The submission of the Nottingham and Nottinghamshire Combined Authority Governance Review and Scheme to the Secretary of State (SoS) for Communities and Local Government took place in early April. Advice is still awaited from the Department for Communities and Local Government (DCLG) about the likely timescales for SoS consideration and statutory consultation periods. An update will be given at the meeting if there have been any further developments.

2.2 Over the next seven months a number of aspects of the Combined Authority will need to be developed so that we are able to function effectively from the date of commencement. A draft work programme has been developed to address four aspects of the Combined Authority's work and it is proposed that specific reports to agree each aspect will be brought to future meetings of the Joint Economic Prosperity Committee over the coming months. Comments on and suggestions about the draft work programme set out below are welcome.

2.3 Draft Work Programme

Governance

- i. Develop specific **lead responsibilities** for the politicians on the Combined Authority which reflect the breadth of its scope of responsibilities and priorities
- ii. Design an appropriate structure of **committees and/or task groups** and consider how membership will be drawn from the Combined Authority and its constituent councils
- iii. Consider the requirement for a **constitution and standing orders** for the Combined Authority
- iv. Consider how the Combined Authority will discharge arrangements for effective **Overview and Scrutiny**
- v. Develop the planned Memoranda of Understanding
 - between N2 partners
 - with D2 (including Erewash)
 - with Sheffield CR
- vi. Set out and implement proposals for the appointment to **Statutory Officer** roles.

Resources

- i. Determine **the initial resource base** for the Combined Authority, drawing on discussions about use of the first year surplus of the Nottinghamshire Business Rates pool.
- ii. Prepare an **annual budget** for consideration by the Combined Authority.
- iii. Determine **Accountable Body** arrangements and consider whether and when the Combined Authority might require its own bank account and accounting arrangements.
- iv. Develop a **Human Resources strategy** and put in place arrangements for staff secondments.
- v. Develop appropriate measures to account for and monitor **'In-kind' contributions** to the work of the Combined Authority.

- vi. Consider the appropriateness of **Financial Regulations and Internal Audit** in any Accountable Body arrangement.

Policy Development

- i. Develop a single **Growth Strategy**, drawing on existing Plans and consider specific policies and strategies that the Combined Authority will wish to consider including:
 - Transport, sites & infrastructure
 - Inward Investment and Place Marketing
 - Skills
 - Growth sectors & business
 - Housing
 - Connectivity
- ii. Consider options to combine and make effective use of **research, information, policy development and analysis capacity** across the constituent authorities.
- iii. Consider options for the potential for **public service transformation** through the Combined Authority.

Delivery

- i. Agree protocols for **leadership of delivery work** by constituent councils on behalf of the Combined Authority and for the Devo Deal managed through the Joint Leader's Board
- ii. Develop a process for the preparation of a future **pipeline of projects and a commissioning process** for the Combined Authority.
- iii. Consider arrangements for **project management, performance and evaluation**.

3 OTHER OPTIONS CONSIDERED IN MAKING RECOMMENDATIONS

- 3.1 An alternative option would be to await the outcome of the statutory consultation before proceeding with the work. However, the Committee has previously expressed its wish to make early progress.

4 FINANCIAL IMPLICATIONS (INCLUDING VALUE FOR MONEY/VAT)

- 4.1 Development of the work programme is largely being covered through contributions of officer time from the constituent authorities. Consideration will be given to the use of resources allocated to the Combined Authority where insufficient capacity is available to progress at an appropriate pace.

What are the European Structural and Investment Funds?

ESIF are the EC's primary mechanism for reducing social and economic disparities across the EU. In England, these funds comprise the following elements:

- **European Regional Development Fund (ERDF)**
 - Supports research, innovation, business development and infrastructure investment
- **European Social Fund (ESF)**
 - Supports skills, enhancing access to employment and social inclusion
- **European Agricultural Fund for Rural Development (EAFRD)**
 - Supports economic development in our rural areas

What are European Structural and Investment Funds?

- In England the accountable body (Managing Authority) for each funding element is:
 - **ERDF - Department for Communities and Local Government. (DCLG)**
 - **ESF - Department for Work & Pensions (DWP)**
 - **EAFRD - Department for Environment Food and Rural Affairs (DEFRA)**
- All monitoring, financial processing and change requests go through Managing Authorities
- Matched funding of 50% is required across the programme
- Payments to projects on defrayment and in arrears (3 months)

D2N2 ESIF Financial Allocations 2014-2020

ESIF is “funding of last resort” and intended to add value to the D2N2 area

- ERDF - £104.4m
- ESF - £104.4m
- EAFRD - £5.5m



What the ESIF allocation will buy in the D2N2 area

ESIF has specific outputs and outcomes: D2N2 have set the following broad targets for the programme:

- **5000 businesses receiving support – e.g. ICT, low carbon, SME competitiveness**
- **400 new enterprises supported**
- **15,000 people supported to find employment**
- **8,000 people supported in relation to social inclusion**
- **2,500 businesses improving skill levels**

Match Funding

- ESIF will fund 50% of the project costs
- Some national bodies will provide the other 50% via “Opt Ins”. In D2N2 the opt in organisations are:
 - Skills Funding Agency
 - Department of Work and Pensions
 - The Big Lottery Fund
- A small proportion of ESF activities require match from the applicant but most ESF projects are via “Opt Ins”
- All ERDF & EAFRD requires match from the applicant

D2N2 ESIF Governance

Lead role for LEPs – notional 7 year allocations

- Developed ESIF strategy
- Agree projects with Managing Authorities
- Monitor project delivery against strategy and programme priorities
- Not responsible for administering the funds (remains with Managing Authorities)



Routes into the ESIF 2014-2020 programme

- Applications for funding from the ESIF can only be submitted in response to a published call for proposals
 - Applies to ESF and ERDF
- The ESIF Programme Board will oversee the investment of ESIF in D2N2
- EPCs to adopt a strategic approach to future bidding rounds

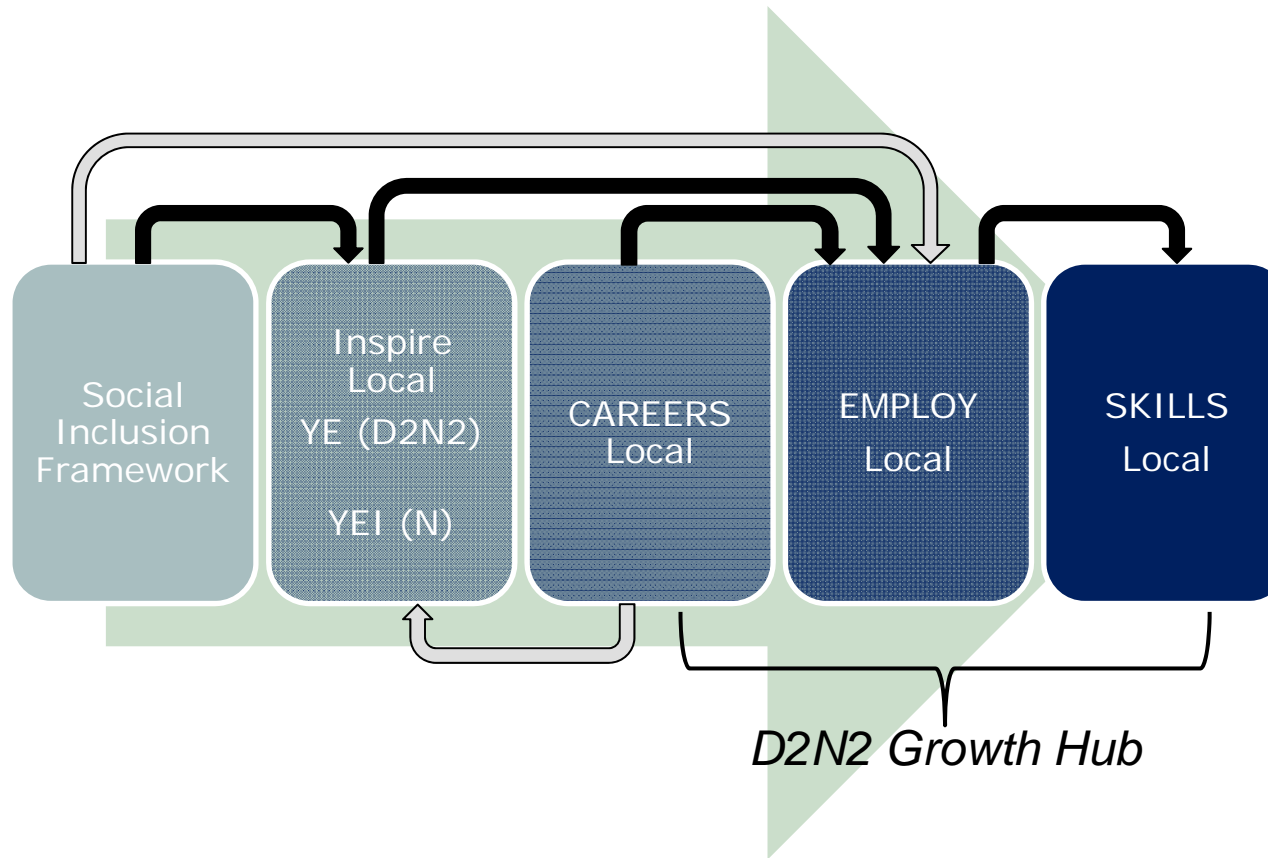

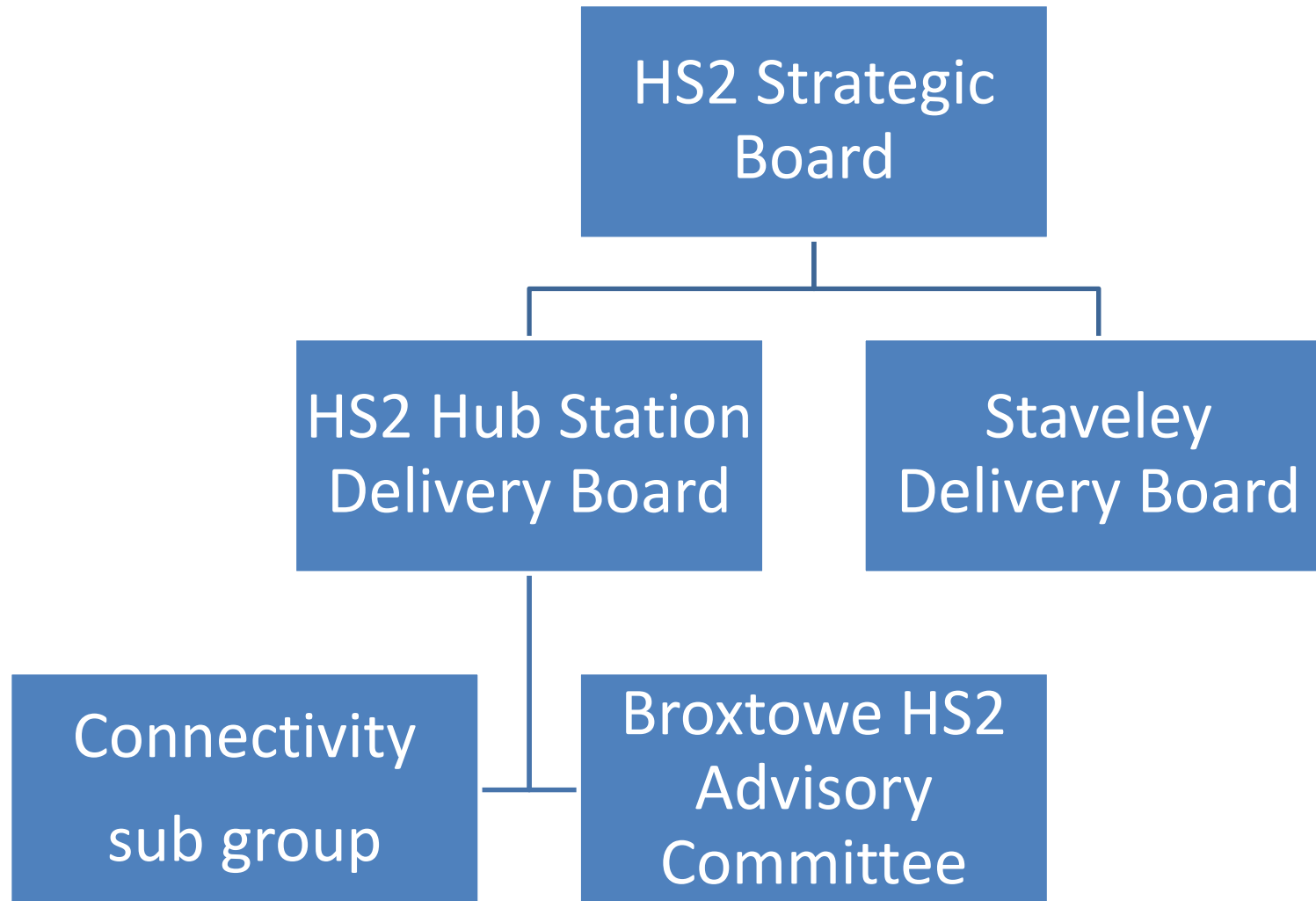

Vision for HS2 in the East Midlands

“Councils, LEPs, universities and colleges will work in partnership with the Government to ensure that high speed rail in the East Midlands delivers unique and sustainable places that are well connected by high quality infrastructure, for people who will benefit from enhanced employment prospects resulting from targeted investment in skills and business support”.

“ Unique and sustainable places..”

1. High quality design that achieves an inspiring 21st century gateway to the towns and cities of the East Midlands
2. Planned development that uses the locational advantages of the Hub station to strengthen and reinforce the roles of existing settlements across the East Midlands
3. Making use of innovative and effective engineering solutions that avoid or mitigate the severance of communities and businesses in Long Eaton, Mansfield, Ashfield, Worksop and Chesterfield.
4. Using land/business rate value uplift to increase investor confidence to address local regeneration priorities and improve areas of low quality housing stock.

5. Ensuring HS2 is additional to current levels of classic service provision and using released classic rail capacity to significantly improve connectivity.

6. Constructing direct links between HS2 and the Midland Mainline to allow some trains to run on both lines, increasing connectivity to Birmingham, the North of England and Scotland.

7. Ensuring local multi-modal accessibility to the Hub station.

8. Using innovative technology such as integrated flexible ticketing to enable seamless multi-modal journeys via HS2, classic rail and other forms of transport

9. Rebuilding pride and excellence in the construction and manufacturing sectors.

10. Maximising the economic potential of the Staveley Maintenance depot.

11. Increasing connectivity to new and existing major employment opportunities .

12. Ensuring local companies have a fair chance to win contracts to design and build HS2 and the required rolling stock.

Promoting the case for the Eastern leg

- Eastern leg delivers greater financial benefit at a lower cost than any other part of HS2 (£4.2bn economic benefit).

Leeds to Birmingham -95 mins

Nottingham to Birmingham – 74 mins

- Essential catalyst for growth: Links 5 of the UK's 10 biggest City Regions with a combined population of over 12 million.

Connectivity

- Links (tram, road, rail) to Nottingham, Derby, Leicester
- Links to East Midlands Airport, East Midlands Gateway (Freight interchange); former Ironworks Stanton
