49 Minutes

The Committee agreed the minutes of the last meeting held on 30 September 2020 as a correct record and they were signed by the Chair.

50 Issues raised by Community Representatives

No issues were raised at the meeting, or had been previously notified, by Community Representatives.

51 Area Partnership/Community Hub

Marie Muir, MBA student at Nottingham Trent University, presented the report, which detailed a proposal to form Partnership/Community Hubs in all areas, with the intention of continuing to support local communities by combining Council and external organisations' knowledge and resources, as has been happening during the pandemic.

Ms Muir stated the following:

- each of the Area Partnerships would have their own distinct ambitions, visions and priorities aimed at meeting the local needs and aspirations of residents living in the wards that fall within an Area Committees' boundaries:
- ii. Neighbourhood Development Officers have been working with Nottingham Trent University MBA students and have carried out research to investigate and recommend which Community Hub model fits better locally to meet the changing needs and demands of the communities living in the areas during and post Covid-19:
- iii. a questionnaire was formulated and distributed to partner organisations to complete, and they were invited to a meeting to discuss the results;
- iv. the questionnaire and meeting were designed to determine the partner organisation's priorities and see if there was a consensus among them. They were asked to select four key priorities from the questionnaire/meeting, based on the themes that had gained most importance during wave one Covid-19 pandemic, relevant to all wards in the area. The return of the questionnaires was too low to be statistically viable, but the analysis is available on request;
- v. the Community Hubs would support the delivery of the Area priorities and help reframe the connections and relationships between statutory, voluntary and faith sectors, change the way services are operating by removing silo-working and barriers and explore opportunities for joint working and funding;

vi. the Area Partnerships would be aligned to the existing Area Committee boundaries and each Area Partnership would report to the relevant Area Committee.

During discussion, it was stated that:

- vii. while it was a useful report, particularly the detail in respect of levels of deprivation in the area, it may not be the right time to implement the proposals in light of the current pandemic lock-down;
- viii. while the report contained some useful information, there had not been enough feedback, and what had been received more likely reflected the current position and needs, which would undoubtedly change once things returned to a more 'normal' way of life.

- (3) that the Committee supports the actions of further consultation, ensuring senior representation and identifying key communication channels, as detailed in appendix 2.
- 52 Police and Community Protection update

(a) Police updates

Inspectors Fenwick, English and Busuttil gave the following statistics / information for year-to-date in comparison to last year:

 Burglary commercial – 3 recently in the Park Lane Commercial area, for which a person will shortly be arrested;

- the rise in drug offences is partly due to Operation Reacher serving successful warrants;
- Basford ward is fully staffed;
- a new Schools Officer is working with the team at Ellis Guilford Secondary;
- a recent stabbing on Britannia Park (resulting in no life threatening injuries) is being
 investigated by CID, with a suspect interviewed under caution. This is thought to be a
 targeted attack, with both parties being known to the Police;
- Covid-19 patrols are still ongoing;
- thefts from shops are a current priority;
- the number of reported incidents of Covid-related ASB and parties etc seems to be across all areas, with no particular ward standing out.

- Operation Reacher has been running for a couple of months, and includes community engagement activities, with the aim of preventing crime, rather than just reacting to it after it occurs;
- over the last couple of weeks, the National Knife crime 'Week of Action' has taken place and a number of weapon sweeps, especially in open spaces such as parks, and no weapons have been found;
- the 'mini Police' and Reacher Team have been creating posters with the aim of preventing crime, particularly knife crime;
- a serious incident occurred on Beech Avenue, with a male brandishing a shotgun. He was arrested and recently sentenced to 3 years 4 months in prison;
- the police have engaged with 150 school children in the Berridge ward, at Djanogly Northgate & Sherwood and St Marys, but unfortunately due to Covid-19, some schools were not accessible, such as Djanogly City Academy. Hopefully this will be resolved soon and as the scheme is ongoing, engagement with more schools should be possible.

- Theft (other) 2 from vending machines at the City hospital, a stolen bicycle and a stolen wheelbarrow:
- Drug offences Operation Reacher recently served a successful warrant, resulting in a large seizure of cannabis, cash and high-value items;

- a shoplifter was recently sentenced to 16 weeks in prison for 20 offences at the Co-op and Boots on Mansfield Road:
- action has been taken against a prolific hoax caller, so hopefully the number of hoax calls to the Police will go down;
- a recent speed operation (on 22/10/20) in Sherwood Dales area resulted in a number of drivers being spoken to. There will be further operations over the next couple of months and Councillors can suggest any areas they would like covering;
- a weapons sweep at Peggy's Park recently recovered a knife, happily a second sweep later discovered no new weapons;
- PC Matt Johnson has left to join the Reacher Team and has been replaced by PC George Browoff.

- due to Covid-19, shifts have been changed so that CPOs work later to check that businesses comply with the regulations. Most are complying, but those that don't have been reported to the Police;
- one member of staff has left from the Basford ward, but this person will be replaced as a new member of staff has joined the team.

53 Nottingham City Homes update
