#### 15 Declarations of Interest

#### 16 Minutes

The minutes of the meeting held on 9 September 2020 were confirmed as a true record and will be signed by the Chair.

#### 17 Policing and Community Protection Update

Nottinghamshire Police Sergeant Ollie Vale provided the following update for the past 2 weeks:

#### **Bestwood**

- a) violent crime and victim based crime has increased but not with any pattern or in any one area;
- b) burglary is down by 75% and there have been no vehicle offences;
- c) shoplifting had increased but this was due to 2 prolific shoplifters who are being dealt with by the Neighbourhood Policing Team;
- d) Anti-Social Behaviour (ASB) has reduced significantly by 45%. This may have been a result of higher than expected reports of ASB at the end of last year in the Lytham Gardens and Hove Road areas which has now substantially reduced;
- e) there haven't been any reported incidents of hate crime within the last 2 weeks;
- f) there has been a sharp rise in criminal damage with the Cherry Orchard Mount area being targeted with arson but a couple of people have been identified as potentially responsible and will be dealt with:

#### **Bulwell Forest**

- g) overall there's been very little movement in reported crimes, but overall down by 2%;
- h) victim based and violent crime has reduced;
- burglary is down along with shoplifting and theft in general, possibly due to managing some disputes and continued good partnership working whereby an injunction was sought for an individual:
- j) there has been a reduction in ASB;
- k) there has been a slight rise in hate crime by one incident. This continues to be from the same sources with no specific individual target for race or religion;

#### Bulwell

- I) there has no movement in overall crime;
- m) only been a slight variance in victim based crimes but a drop in violent crime;
- n) shoplifting has slightly increased as is seasonal with Christmas coming. Shops are offered advice;
- o) a slight rise in criminal damage but without any identifying pattern;
- p) vehicle crime down;
- q) ASB and hate crime have reduced.

#### Operation Reacher

- r) Operation Reacher, which was initiated in Bestwood area and provided additional area focused staffing and resources, has now been rolled out across the whole of the City North Policing Area including Bulwell and Bulwell Forest since November, with the majority of activity in Bulwell and Bulwell Forest:
- s) there have been 24 arrests, 7 traffic prosecutions, 34 instances of stop and search, 10 arrest warrants issued, and £14,000 recovered from the proceeds of crime, and 12 drug seizures including heroin and crack cocaine. This work leaves the Neighbourhood Policing Team to focus on neighbourhood policing.

Bestwood, Bulwell and Bulwell Forest Area Committee - 9.12.20 In the absence of Senior Community Protection Officer Daryl Paxford, the following update was read out:

- t) 79 Fixed Penalty Notices have been issued across the wards for offences relating to fly tipping, littering and dog fouling;
- u) City-wide operations to tackle anti-social behaviour are being supported by a dedicated ASB Car, which provides extra resources later at night;
- v) Community Protection Officers have been assisting with covid-secure business checks and also ensuring businesses are compliant with their legal obligations throughout the pandemic. As well as this officers have been in high profile locations and transport hubs to provide reassurance, advice and help enforcement;
- w) a Community Protection Officer has recently been seconded to a Covid Response Team to support activity around compliance, welfare checks and other covid related matters;
- x) Margaret TRAFFORD, the School Crossing Officer for Rise Park has taken the decision to and retire. Margaret has served in all weathers with dedication and a passion for the safety of the children. We wish Margaret all the best for the future and will be recruiting for a replacement. We are currently working with the school to see if any local parent/grandparents/.guardians would be interested in the position.

#### 18 Digital Inclusion - Connected Nottinghamshire

Rosie Atkin of Connected Nottinghamshire, informed the committee of the digital inclusion work being undertaken across the county to help and support citizens to improve their social and digital inclusion skills and ability. The following points were highlighted and questions from the committee responded to:

- this area of work was established as a result of research undertaken in 2018 and several support schemes have been launched to help promote digital communication across the whole community;
- b) the predominant focus for digital inclusion is to increase digital access and interaction with the health sector, but also within and between communities and partners;
- c) the gaps in digital inclusion were recognised prior to the pandemic, but lockdown has highlighted the vast range, and high levels of digital deprivation in relation to access to the internet, devices and also ability;
- d) initially schemes were taken into the community with face-to-face support at digital pop-up hubs at community venues and in job centres, as if a roadshow, but due to COVID-19, a different approach has been taken and support is now provided by telephone;
- e) in addition to community and citizen support, there is a Digital Champion Scheme which trains staff and community workers, such as receptionist at GP surgeries, to teach and assist citizens/patients with digital communication, such as for online booking of appointments and services, and accessing the NHS App to access health information, enabling them to then support other people;
- f) during the past two months approximately 77 citizens have contacted the service for support. This may appear a relatively low figure, but each engagement may take a substantial amount of time and the Digital Inclusion Team only consists of three people;
- g) the Digital Workforce Package is available for small businesses;
- h) the 'Tablet Lending Scheme' pilot is aimed at voluntary and community services and organisations to help encourage digital access and ensure members stay connected. The pilot

Bestwood, Bulwell and Bulwell Forest Area Committee - 9.12.20 scheme has been well received and is currently operating with one community group but there has been a lot interest shown from other groups;

i) tackling the inequality in digital inclusion requires a partnership approach and can't be achieved in isolation so it is important that the Community and Voluntary Sector, partners and individuals promote the roll-out of the opportunities offered.

Councillor Cheryl Barnard, Portfolio Holder for Children and Young People, commented that inequality of internet access within the City has recently been highlighted for school children during the first lockdown when they were required to work from home. It was found that some families were relying on just one device, often a mobile phone, for digital communication. As a result, the Education Department of Nottingham City Council worked to provide laptops to some particularly vulnerable families and although some Central Government funding was provided, the City Council used the pupil premium to support the digital inclusion agenda.

#### Resolved

- 1) to note the valuable work of Connected Nottinghamshire;
- 2) to record the Committee's thanks to Rosie Atkin for her presentation.

#### 19 Bestwood Advice Centre

Sue Foster, Manager and Senior Advisor at Bestwood Advice Centre delivered a presentation which is circulated with the initial publication of the minutes, and highlighted the following points:

- a) Bestwood Advice Centre is based on Gainsford Crescent and has been operating since the 1980s, providing advice and support for citizens on issues such as debt and financial management, insolvency options, tribunals, utility debts, and welfare applications;
- b) the main source of funding for the Advice Centre is currently from the City Council, but with other short-term contributors including British Gas, Coalfields, lottery, a pilot scheme of support with Life After Debt, and Bestwood Partnership;
- the advice centres across the city work together as a consortium of Advice Nottingham to achieve funding, watch for trends and work to advise and support citizens, include working in partnership with multiple local organisations;
- although usually a face-to-face service, due to the COVID-19 restrictions adaptations had to be made to remote and online working. This was achieved quite rapidly, including providing further information via social media. Following lockdown only very limited access in person was offered for extreme circumstances;
- e) last year the service worked with a Nottingham University in providing a 4 week internship to a student. To make the most of this opportunity, Sophie worked with the service for 4 weeks researching the need for advice centres and the value they bring, not only to the individual but to the community as a whole. This project resulted in some excellent research and culminated in a presentation to local partners and agencies, which will also be used to support funding applications. A copy of the report is available electronically on request. Sophie has remained working with the Advice Centre and is now on the Board as Treasurer;
- f) COVID-19 has resulted in a rise in demand from the centre with many people have not claimed benefits or accessed the service previously, now requesting support, often with multiple issues.

The majority of support is provided over the phone and via WhatsApp photos or by post if people aren't connected;

- g) utility companies have proved very difficult to deal with, especially as they generally hadn't adapted their working practices due to the COVID-19 restrictions, and some almost verged on obstructive;
- h) it has been highlighted that more financial education is needed to prevent or address poor budgeting and poor financial choices. Talking to some citizens about changing their financial behaviour and choices has been difficult, particularly over the telephone (rather than in person) as some people find it easier to express their anger and frustration at a distance;
- i) during the past 9 months approximately 500 clients have been supported, which is similar to the number of people supported in the previous 12 months. Some client cases require a huge dedication of advisor time, sometimes in the region of 100 hours, particularly where there is digital exclusion;
- j) often when clients approach the Service they are already in debt, do not have capacity to save, and cannot afford to take on further debt even via a credit union loan, so it is rare that clients are referred to credit unions, although they may be included in the financial education work where citizens have the capacity to save;
- k) issues that need highlighting include:
  - i. the extra £20 per week for people on WTC and UC benefits during the pandemic is only temporary, but as it occurred at the same time as the increase in benefits, many recipients haven't realised that this will stop/reduce in April 2021;
  - ii. Council Tax benefit was temporarily increased but will revert in April 2021, again, many recipients haven't realised this;
  - iii. debt reclamation charges from benefit payments were temporarily stopped but are now reintroduced at a much higher rate;
  - iv. digital exclusion, however a campaign has been launched to target the digitally excluded and hard to reach residents in Nottingham with the ability for the Service to contact them by phone or post;
- the pandemic has resulted in a lot of additional work and community and individual need, which is predicted to rise significantly, so funding has been secured for 2 part time advisors to support the work but further funding will be needed to enable the need to be met. All routes for further funding are being pursued although most current funding availability is either only COVID-19 related so time limited, or short-term and it's difficult to recruit to short-term posts. Engaging a part-time, results based payment fund raiser is being considered;

Members of the Committee expressed their appreciation of the Bestwood Advice Centre's work, congratulated the Team on their achievements and were concerned at the inevitable rise in demand and reducing funding.

Donna Denning of Bestwood Partnership, added that the Advice Centre also provided support for citizens with white goods, which is key for some citizens to store and cook food. The Bestwood Partnership is currently looking at financial education schemes to help support budgeting and money management.

Rosie Atkin of Connected Nottingham offered to help support the digitally excluded work of the Service.

- 1) note the valuable support and advice provided to citizens by the Bestwood Advice Centre;
- 2) record the thanks of the Committee to Sue Forster for her attendance and presentation.

#### 21 Good News Stories

The Committee were informed of the following good news reports and community updates;

- a) Reverend Andrew Fisher asked that the Committee be made aware that the Bestwood and Bulwell Foodbank has opened a once weekly session at St Mary's Church on Highbury Road, which will make it easier for people in the area. Referrals are through the usual routes;
- b) Chris Easton updated the Committee on the work taking place at the Bestwood Park Church, with Friday meal deliveries continuing and next week marking the delivery of the 6,000<sup>th</sup> meal since 27 March 2020. There is still a need with approximately 50 meals sent out on 17<sup>th</sup> November and 150 festive meals due to be delivered with the help of the community groups and partners, including the Fire and Rescue Service on Christmas Eve, along with 450 hampers. The national 'Love Thy Neighbour Scheme is active in the area;
- two local mothers had recognised that some families were struggling to buy Christmas presents for children and organised a Community Christmas Gift Scheme at the church with presents wrapped by care home residents of Hawthorne Lodge. Approximately 250 gifts have been donated and will be distributed prior to Christmas;
- d) there is also now a foodbank operating twice a week in the Crabtree area on Tuesdays and Thursdays, 9am-3pm;
- e) Maria Shakespeare is still planning to cook and deliver Christmas meals to elderly residents in the community, as she does every year.

#### 22 Nottingham City Homes Update

Nottingham City Homes Area Housing Managers Nicky Brake presented the report which provides an update on performance, activity and engagement, and in an updated Appendix 3, which has been circulated as a supplement to the agenda, requests scheme approvals.

Members of the Committee requested an update item to a future meeting regarding the housing developments in Bestwood and Bulwell, including the proposed timelines. It is noted that one scheme is private and the other is by the City Council, and not NCH, but an update can be considered as a standalone item for a future meeting.

#### 24 Bestwood, Bulwell and Bulwell Forest Area Partnership / Community Hub

Celia Knight, Neighbourhood Development Officer, presented the report which provides an overview of the establishment of the Area Partnerships and Community Hubs. Detailed local statistics, including the indices of deprivation, health, education, housing, crime, and age relevant issues are included within the report, including a survey of community organisations within the Area.

It is noted that much of the partnership working has evolved naturally to respond to the needs of the community during COVID-19. Scheduled work, including the establishment of sub-groups to consider and look to address identified local priorities has commenced with positive outcomes to date.

It is proposed that a leaflet will be distributed to 22,000 local properties which will provide useful contact numbers as there are concerns that it is difficult for people who do not have access to the internet to find out where to obtain help. This has been funded by the Bestwood Partnership.

#### 1 Reasons for recommendations

- 1.1 The Nottingham LTP strategy 2011-2026 maintains a commitment to deliver local transport improvements across Nottingham's neighbourhoods and prioritises small-scale transport improvements of importance to local communities.
- 1.2 As part of the budget process Nottingham City Council approved at the Executive Board meeting on 18 February 2020 an LTP capital allocation of £1.25 million citywide between 2019 -20 was approved. At the same meeting a citywide allocation of General Fund Element (public realm) of £750,000 was agreed. At the subsequent Executive Board meeting on 21 July 2020, as part of the budget update, a top-slice of 20% was made to the General Fund Element (public realm) reducing it to £600,000.

#### 2 Background (including outcomes of consultation)

- 2.1 The Area Capital Programme was established to improve the environment of the neighbourhoods and to create a sense of place for residents in order to improve the quality of life of local people. Since its establishment in 2006 to meet the then corporate priority of 'Transforming Neighbourhoods', the Area Capital Fund has included a total programme expenditure portfolio of £40 million. The improvements that have been carried out to date using the programme have included footpath construction and repairs, fences, visual enhancements to public realm, refurbishment of parks and improvements to public buildings.
- 2.2 Resources are allocated from the Nottingham City council general fund, the Local Transport Plan (LTP) and from the Housing Revenue Account. To achieve a joint approach to environmental improvements in neighbourhoods, a greater degree of flexibility has been established to prioritise and deliver improvements so that there is a synergy in local solutions for local issues across neighbourhoods.
- 2.3 The programme of works is a rolling programme. There have been instances where schemes are started, with strong community involvement and interest, only to be altered at a later stage due to changing circumstances such as economic conditions and changes in land values.
- 2.4 The Area Committee, particularly community representatives, are invited to comment specifically on those schemes identified in the proposals column and to consider whether certain schemes can be linked to other programmes of work in order to generate best value and create a greater impact on the local area.

### Bestwood, Bulwell and Bulwell Forest Area Partnership Update

The first meeting of the Bestwood, Bulwell and Bulwell Forest Area partnership meeting took place in November and included a range of partners from statutory, voluntary, community and faith groups and ward councillors. At this meeting, it was agreed that the initial priorities to work on should be mental health and isolation, food poverty and benefits, the community hub and communications and separate sub groups were set up for each of these. Employment was also seen as a priority but this was already covered through the exiting Employment and Skills Area Partnership chaired by Cllr Lakey. The sub groups have all met since November and reported back to a full partnership meeting in January.

#### Communications sub group

The communications group met very quickly as it had been identified that there was a need to get information out to as many residents as possible about support services particularly as a significant number did not have access to the internet and all of their usual ways of obtaining information and support were currently closed. The group worked very hard so that an A5 double sided leaflet, funded by Bestwood Partnership, was produced and distributed before Christmas. This has already resulted in some residents receiving support which they otherwise would not have known about eg from Bestwood Partnership and Bestop Kitchen. The sub group is aware that ensuring that everyone has access to information is important going forward eg if English is not the first language and will meet again if there is further work which can be done to increase access.

#### Mental Health and Isolation

This sub group has met once and discussed the low numbers of organisations which were able to provide any form of social support to individuals who were isolated eg all of the lunch clubs and community groups were currently closed. Knowledge of what was still currently able to operate was shared. The useful telephone numbers leaflet had provided information on helplines to residents and some groups were able to provide limited support. It was agreed that, once restrictions are lifted, a stall should be held in Bulwell market place and possibly other locations with information about local services and activities. It was also agreed to explore whether a city wide group of mental health support services existed which one or more people from the partnership could link into and share information which may be helpful to local residents. The group will meet again in February.

#### Food Poverty and Benefits

This group has met three times as it decided to focus initially on ensuring that anyone across the 3 wards who needed access to free food over the Christmas period could access the help they needed. Information was shared amongst partners about the services on offer from organisations such as Crabtree Community Centre, Pythian and Bestop Kitchen. It was identified that part of Bulwell Forest ward would not be able to access the hot meals available the week before Christmas to vulnerable residents in other wards and Bulwell Forest Garden agreed to fill this gap. Referrals for the projects available were distributed to partner agencies. Further partnership work and communication is still needed to ensure that people who need the help the most receive it and to avoid duplication. Organisations

requested that a city wide meeting be set up which the partnership could link into and someone from Nottingham City Council attended the next meeting to discuss the best ways of linking into a city wide group which is due to start in the next couple of months.

No work has been undertaken to date on the benefits issues. Alex Norris MP also be attended the last meeting as Rebalancing the North is also interested in food poverty issues and is keen to avoid duplication.

#### Community Hub

This sub group has met once and had a lengthy discussion about what any "Community Hub" should look like eg should be an information hub or one which provides services or both. In the absence of significant amounts of new funding, it was agreed that initially the aim of community hubs was to ensure that all residents, regardless of where they live in the three wards, should be able to know where they can easily access advice and information about services which are available. The list of places shared at the meeting of where people already access information was extensive and included schools, Riverside, online sites, community and faith groups, leisure centres, GP surgeries. However, it was clear that many front line staff did not always have up to date information on all the issues which they had to deal with thus restricting the level of support given. Ways of increasing this knowledge were discussed and included the need to strengthen the Ask Lion service. Initially, it was agreed that all organisations would check that their information on Ask Lion was up to date and would check with their front line staff what additional information would be useful. Work is being done within Nottingham City Council to improve the Ask Lion Service and this will be reported back to the sub group as it progresses. It was agreed that, in the absence of significant additional funding, strengthening the existing information networks in all 3 wards would be the most effective way of improving information to residents. The group will meet again in February.

#### Partnership Funding

An additional sub group has met twice due to the opportunity to access funding for funding partnership working. The initial funding opportunity deadline proved too tight but the groups will meet again in three month's time to look at the possibility of applying funding to further the partnership's aims.

#### Conclusion

The partnership has only been in existence since November but the strength of the working relationships between partner organisations and the commitment to trying to improve outcomes for local residents during a crisis has been reflected in the willingness of very busy people to give up time to progress and move suggestions forward. A very big "Thank You" to all the partners involved.
