#### 40 Minutes

The minutes of the meeting held on 14 January 2020 were confirmed as a true record and were signed by the Chair.

#### 41 Area Policing update

Sergeant Richard Hunter, Nottinghamshire Police, provided an update on year to date crime statistics detailed in the table below.

During discussion, the following points were made:

- (a) The rise in theft number in St Ann's is as a result of increased Theft from shops offences;
- (b) The increase in burglary figures in the Sneinton area is as a result of a number of business burglaries, not domestic burglaries;
- (c) Theft of catalytic converters continues to be an issue across the city. There have been a small number of thefts of this type at the Racecourse Park and Ride site. Work is underway to track the path of the components. This is an ongoing investigation;
- (d) Reacher teams will be rolled out across the force. These teams are proactive neighbourhood teams should all be in place within 12 months, and follow on from the success of the pilot team based in Bestwood;

The Committee noted the information provided within the update and thanked Sergeant Hunter for his attendance.

#### 42 Issues and good news stories

Community Representatives gave a verbal update on issues and good news stories since the last meeting in January 2020.

Pete Wright – Sneinton Tenants Outreach Programme informed the committee that the group had been nominated for a number of awards at the Nottingham City Homes awards. The Committee congratulated Pete on the groups continued hard work.

Bishop Carlton Napier gave a brief update on the work of the Afro Caribbean National Artistic Centre's work. He informed the Committee that work to refresh and reestablish the centre as a community hub is underway. Upcoming focus will be on health initiatives reaching out to the more hard to reach communities, in order to raise awareness.

The Committee thanked the Community Representatives for their attendance, and for their continued hard work in the community and noted the content of their update.

#### 43 Health within the Area

#### 43a Ward Health Profiles and Local Health Priorities

Alison Challenger, Director of Public Health, and David Johns, Consultant in Public Health gave a presentation summarising the Ward Health Profiles and Local Health Priorities for the Dales, Mapperley and St Ann's Wards. They highlighted the following points:

- (a) There have been a lot of changes within the NHS in recent years and it is important to keep up with the health issues that are affecting citizens at a ward level;
- (b) The County of Nottinghamshire, excluding Bassetlaw has been divided into 3 partnership areas, City, South County and Mid Notts. Within the City partnership there are 8 Partnership Care Networks (PCN's), these PCN's mostly align with the City Council Area Boundaries, the PCN for this area is Nottingham City East;
- (c) The Ward Health Profiles are available on-line and aim to start a conversation with partners regarding the health demographic for each ward;
- (d) There is an 8 year gap in life expectancy between the least deprived and the most deprived areas of Nottingham City, with male life expectancy being 77 years, and female life expectancy being 81.1 years. Both of these figures are less than the England average;
- (e) Healthy life expectancy is also below average, with females born in Nottingham having a healthy life expectancy of 53.3 years – this is 10 years less than the England average and means females born in Nottingham can expect to spend more than a third of life in poorer health;
- (f) the impact of environmental factors on health should not be underestimated. Risk conditions such as poverty, unemployment, lack of social support, isolation and poor social networks all contribute to ill health;

- (g) smoking prevalence is higher in both St Ann's and the Dales wards than it is across the City.
- (h) There are a high proportion of children in year 6 that are overweight or obese in St Ann's and Dales Wards than the Nottingham average
- (i) 6 out of the 7 GP Practices within the three wards record significantly higher prevalence of mental health illness than the England average;
- (j) The introduction of Link Workers and Social Prescribers has begun to tackle to environmental factors impacting on citizens health;
- (k) The Ward Health Profiles are designed to give a snapshot of the demographic of the Ward and to give an overview of health priorities;

Following questions and comments from the Committee the following further information was highlighted.

- Mental health is a significant issue within the area. Despite a more open approach to talking about mental health there is still stigma attached to mental health issues and in some communities it is still not talked about. Breaking down the stigma and allowing people to access support is one of the main tasks in this field;
- (m)The Ward Health Profiles will be published on line along with other health and wellbeing information. This will aid commissioning of services and allow the third sector to establish what services to plan, as well as link with similar services in different areas.
- (n) There are not statistics available at a ward level on levels of malnutrition. It is accepted that deprivation can lead to a poorer quality diet and restrict access to good quality, nutritious food. There are a number of third sector organisations working to address this issue and holiday hunger with the city;
- (o) Members of the Committee commented on the access to good quality fresh food in the wards, indicating that there were more fast food take away than there were shops selling fresh, healthy foods;

The Committee asked for further information on accessing services and health fairs etc within the Wards. This will be distributed so that Councillors and Officers have the details to give to citizens.

The Committee invited Alison Challenger and David Johns to return to the Committee to report on progress in 12 months time.

# Resolved to note the information presented in the ward profiles and to feedback opportunities for partnership working as they arise.

#### 43b **The Local Primary Care Network**

Dr Hussain Ghandi, Joint Clinical Director of Nottingham City East PCN and Robana Hussain-Mills, Deputy Clinical Director of Nottingham City East PCN gave a

presentation on the Primary Care Network system in Nottingham with a focus on Nottingham City East PCN. They highlighted the following information:

- (a) Nottingham City East PCN covers 7 practices and around 67,000 people in total. The PCN is not a legal entity but a collaboration and partnership of practices;
- (b) The aims of the PCNs is work with other practices and community and voluntary groups to stabilise general practice and improve the health of the local population;
- (c) The PCNs also have health priority documents looking at issues such as deprivation levels, demographics social and health needs, and these are helping them to target commissioning and resources to be most impactful;
- (d) Nottingham City East PCN has a number of aims for 2020/21 including:
  - Structured medication reviews for complex patients
  - Review of care home patients
  - Improving cancer awareness and screening
- (e) There are a number of challenges to address.
  - Recruitment can take a long time to find the right candidate and appoint them.
  - The physical space to see and treat people has been decreasing as smaller practices close and buildings get sold
  - The public are still very focused on seeing a GP when this is not always the best treatment option. Changing public perception and encouraging the public to adopt new ways of accessing healthcare is important.
  - There is more of a move to online consultations and video appointments. Ensuring patients are digitally literate and that systems can integrate is more important than ever before.
- (f) The rolling out of Patient Knows Best, an online system that allows professionals and patients to see their records is speeding up consultation times and review times. Patients have reported that they feel more empowered and more informed about their health care and treatment options;

Following questions and comments from Committee members the following additional informal was highlighted:

- (g) Government funding has allowed the PCN to employ new patient facing staff, a Network Pharmacist, Link worker and Social prescriber. There is also additional funding for further staff. The recruitment will commence once the PCN has assessed which positions would have the greatest impact on outcomes for patients;
- (h) Communicating with patients the importance of seeing the right healthcare professional is key. Patients have to realise that seeing a GP is not always the best or most appropriate option;

The Committee thanked Dr Hussain Ghandi and Robana Hussain-Mills for their attendance and noted the information they had provided.

The Committee asked that they return to the Area Committee to provide an update in 12 months time.

#### 44 Recent Major Developments

Mark Lowe, Head of Housing & Regeneration, and Martin Poole, Area Planning Manager, gave a presentation updating the Committee on the Major development that are taking place and that are planned within the area. They highlighted the following information:

- (a) After years of planning and delays the Waterside development is now well underway. The development is a mix of residential and business properties, with green spaces and will include a 420 space primary school;
- (b) There are a number of developments across the area, including the former Morley School site and Wainright House where development has now been completed and properties been made available;
- (c) There are also a number of sites where plans have been submitted and are being developed which include a mix of residential properties, and public spaces, and include an element of social housing. These sites include the former Woodborough Inn site and the former Ellis School site;
- (d) The Eastside area of the city has been identified as a regeneration area for many years. Progress has stalled due to a number of issues but has recently been reinvigorated and a number of sites are now at the point of having planning permission, or identified as potential future development sites;

The committee asked a number of questions and the following information was highlighted:

- (e) Planning managers regularly meet developers and work with them to create developments that fit into the area, and works with the existing buildings. Each development is a working and changing project;
- (f) There are a number of developments in the planning phase that will be student accommodation. The Committee raised concerns about the number of student developments in a relatively small area, and how this will impact on residents, and existing services. The committee agreed that although welcoming students to the city is hugely beneficial, the appropriate placement of the developments is essential to ensure existing communities are not adversely impacted.
- (g) Concerns were specifically raised about whether the existing infrastructure was in place to ensure that students who will live in the planned developments are able to access services. GP practices are already stretched and although students are advised to register with the practice on campus, many prefer to register closer to where they live;
- (h) The committee were pleased that many of the developments planned included elements of social housing. They highlighted that the need for social housing in Nottingham is growing faster than the developments are being built and that

planning colleagues should focus on this element and encourage developers, where appropriate, to include social housing;

 (i) The Borough Courts flats development has stalled in recent years. Many residents are wondering what is happening with the site. Planning colleagues confirmed that they were working with the developers to ensure that plans are appropriate for the site and hope to bring the development forward soon;

The Committee thanked Mark Lowe and Martin Poole for their presentation and the information it contained.

The Committee invited planning colleagues to attend the area committee in 12 month's time to update the committee on planned major developments.

#### 45 Parks and Open Spaces

#### 45a Parks & Open Spaces Investment Plan Updates

James Dymond, Parks & Open Spaces Development Manager, introduced the report updating the Committee on the Investment plans for parks and open spaces within the area. He informed the committee that these plans were updated on an annual basis and in consultation with Ward Councillors and Council colleagues.

Ward Councillors for the Mapperley Ward raised issues for the Mapperley Ward and Officers agreed that they would meeting with Ward Councillors to reassess the investment plan for the Mapperley Ward.

The Committee thanks James Dymond for his continued hard work and liaison with Ward Councillors to achieve the best for Wards.

#### **Resolved to:**

- (1) Endorse the updated investment plan to guide future development of the City's parks and open spaces; and
- (2) Endorse the allocation of the Dales and St Ann's allocation of Section 106 funding and for the Mapperley funding to be discussed further.

#### 45b Future Parks Accelerator

James Tilford, Future Parks Accelerator Programme Manager, and Christine Duckwork, Future Parks Accelerator Officer gave a presentation on the Future Parks Accelerator (FPA) fund. During discussion the following points were highlighted:

- (a) The Council has secured funding through the FPA to find innovative and original ways to manage parks and open spaces. There are 4 key areas for development, including:
  - Commercial opportunities
  - Community engagement
  - Charitable foundations
  - Future Governance

- (b) The project with work together with local communities and deliver a 25 year strategy identifying the key areas where opportunities to change how parks and open spaces are delivered;
- (c) A consultation is due to start on 15 March 2020 for citizens. An online survey can be found on the Nottingham City Council Website, more information can be found at <u>www.parksfornottingham.co.uk</u> and on Twitter: @NottinghamFPA

The Committee thanked James and Christine for attending and for the information within their presentation.

#### 46 Nottingham City Homes

Luke Walters, Area Housing Manager, Nottingham City Homes introduced the report updating the committee on key issues and themes, which link back to local priorities and the strategic themes for Nottingham City Homes.

Luke highlighted that William Chambers of Westville Gardens, St Anns has been shortlisted for a prestigious TPAS (Tenants' Participation Advisory Service) Award. He has been shortlisted for the Lifetime Achievement Award celebrating people who have gone above and beyond for their community. The award ceremony is due to take place on 27 March.

The committee expressed thanks to the Staff of Nottingham City Homes, the emergency services and to residents of Manvers Court for the calm organised and thorough approach to the recent bomb scare. They thanks residents for their patience, which allowed professionals to do their jobs quickly, efficiently and safely.

- 1.1 The Nottingham City Homes Update provides a descriptive and statistical picture of what is happening at an area level and invite community representatives to comment, debate, and challenge and identify how they can add value to improve their neighbourhoods.
- 1.2 The update also monitors progress in the wards and acts as a catalyst for debate about the key performance issues impacting upon the ward on a quarterly basis.

#### 2 Background (Including Outcomes Of Consultation)

- 2.1 Nottingham City Homes previously reported on performance at local Area Panels that sat below the respective Area Committees. These panels were attended by local residents, local Councillors and partner agencies.
- 2.2 Nottingham City Homes has a goal to 'create homes and places where people want to live' and to give tenants and leaseholders an input in shaping what happens in their area. The Nottingham City Homes Update and Performance Report is one of a number of initiatives that increases the transparency and accountability of the Company's performance.
- 2.3 Following the decision for Nottingham City Homes reps to attend Area Committee, it was decided to provide the Nottingham City Homes Update Report to Area Committee. Appendices 1 and 2 provide the latest performance position for the committee to note and comment on.
- 2.4 Appendix 3 outlines the remaining capital budget for this area for noting and provides detail of the schemes that require approval by the Committee.



#### Summary of issues (including benefits to citizens/service users):

This report informs Committee of the steps and measures taken to date by the Neighbourhood and Community Engagement Team, Partner Organisations, Voluntary Organisations and Volunteers during the COVID 19 pandemic in the three wards, Mapperley, St Ann's and the Dales Ward.

### Recommendation(s):

1 To note the progress so far offered to citizens during the COVID 19 pandemic by the Neighbourhood and Community Engagement Team and Partners (Appendices, 1, 2, 3, 4, 5, 6, 7 and 8).

#### 1 Reasons for recommendations

1.1 It became apparent week commencing 16<sup>th</sup> March 2020 at the height of the COVID 19 Pandemic that there was a need for a city-focused citizen response to the pandemic rather than joining the County offer of a 'Golden Number'. Resources were quickly mobilised and a work stream developed with Customer Services and other key stakeholders to understand the requirement and agree a process to enable citizen needs to be dealt with appropriately9

- 1.2 A new service was designed by creating 7 Area Clusters aligned to the 20 wards and the Area Committee structures to support the Community hub. The website running alongside the hub was operating 7 days a week and cases were coming through late evening and the weekend. NDOs were able to very quickly adapt to the emerging situation by changing their traditional roles to Cluster Leads and Deputies and managing a team of 5/6 staff deployed from multi-disciplinary teams across the council.
- 1.3 The events and activities detailed in the report take into account the work undertaken by Neighbourhood Development Officers (NDO's) with partner organisations within each Cluster.

#### 2 Background (including outcomes of consultation)

- 2.1 To support the Mobilising Civil Society work stream, the Neighbourhood &Community Engagement team delivered two main strands of activities with additional activities supporting the Voluntary and Community Sector whilst working with internal colleagues.
- 2.2 A decision was made that Neighbourhood Development Officers (NDOs), who have unique community based working skills, local intelligence, co-ordination and problemsolving skills as well as strong working relationships with frontline services, community organisations and residents would be best suited to match support for residents.
- 2.3 Neighbourhood Development Officers utilised their strong, close working relationships with local community organisations, residents groups and community champions to create Local Resilience Teams (LRT) in each ward, mobilising volunteers to help and support vulnerable citizens. NDOs already had trust and confidence within the community and knew large numbers of people who wanted to help.
- 2.4 The LRT's were able to offer early intervention and problem solving to meet citizens need at the first point of contact. This often combined support from a number of support services to the need of the individual. This approach has proven highly effective, and minimized the demand for support from the Adult Social Care service.
- 2.5 Volunteers allocated to the Cluster Resilience teams who were recruited by our Policy and Development Officer leading on volunteering with NCVS have been instrumental in collecting and dropping off food parcels from food banks, picking up prescriptions, shopping and offering befriending calls to isolated citizens within the wards. The good will, enthusiasm and community spirit offered from local volunteers was exemplary and able to meet local demand in a matter of hours.
- 2.6 Initially, the increased volume of cases coming through the dash meant staff working 12hr days, and at weekends to meet demand. Some cases were very complicated and emotionally challenging and draining. As a result, rotas were introduced to shorten the working day to support staff's wellbeing, resilience and help staff utilise the toil they had accrued to meet the business need and urgency of the support required. The Neighbourhood Development offer normally retains 12 Fulltime Employees. As demand for support increased in mid-April, additional staff were redeployed from Community Protection, Sport & Leisure, Libraries and Museums.

This increased the number of staff responding to calls markedly and there were approximately 28.5 (FTE) staff working in the cluster hubs.

- 2.7 The recruitment of volunteers were managed in partnership with Nottingham Council for Voluntary Service (NCVS) who manage the Nottingham Volunteer Bureau. Already recruiting citizens to support VCS organisations, NCVS were able to add the council to their recruitment processes.
- 2.8 Volunteers contact NCVS to register (phone or online) for one of a maximum of 4 opportunities that were offered city wide (this was decided at the beginning of the response to simplify things) and once registered, a list of organisations hosting these opportunities were emailed to the potential volunteers for them to contact directly.
- 2.9 The registration from NCVS were returned to the Policy and Development Officer (the council lead on volunteering) who processes the application and collected references. Once references were received the Policy & Development Officer sent a welcome email to introduce them to their cluster. The Cluster Leads were responsible for assigning volunteering activities to each volunteer.
- 2.10 Since the launch of the Community Hub, the Clusters dealt with over 3000 cases to date, not including cases already supported/cleared by N&CE staff. The main strands of activity were:
  - Co-ordination and delivery of support to citizens who have made contact with Nottingham City Council through the customer hub and the online service.
  - Recruitment and engagement of volunteers in order to meet the needs of citizens.








Table 3: No of requests by the method of contact



He had received a food parcel but did not know where from and was not sure if he was on the shielding register. An officer made some checks and rang for a chat with her. Her father was not on the register and she was advised to check with his GP and how best to register him. The officer rang through all the other options available if her father was in need of help and support, including Age UK, Meals at Home local volunteer groups. She was very happy with all of these options and said we at NCC are doing a really good job. She said she would come back to us if necessary.
Dales, Mapperley and StrAnns	Mapperley	A gentleman contacted us on behalf of his very elderly mother, who lives in Mapperley. He is not able to get to visit at the moment but had concerns about the household, as his mother is receiving kidney treatment three times a week, and he has a very disabled sister who is not currently able to attend her normal day centre. His other sister cares for both of them. Long term plans are in place, but in the short term, the carer is self-isolating to protect her mother. They have the means to pay for food, and were referred to Disability Support to ask for support with shopping in the short term, and for hot meals at the weekend. This was agreed and put in place. The officer spoke to the carer who said everything had worked well and it had been extremely helpful to have the weekend meals; she wondered if these could possibly continue. The officer discussed the Age UK telephone befriending service for her mother, but this was declined as she is hard of hearing. She also discussed other support options including specific support for carers. The officer followed this up a week later and confirmed that Disability Support they will provide ongoing meals and a fortnightly shop for this family until the disabled daughter can return to the day centre. Contact numbers have been provided to the carer for Age UK, Meals at Home and Disability Support, as well as for the Carers Hub who should be able to offer respite care for her sister. She also has the Social Services number in case of need. She was very happy with the support provided by the customer hub

Dales, Mapperley and St A St Anns		An elderly St Anns resident reported having no food in the house and asked for some urgent help with shopping. An officer checked with the citizen and found that he had sufficient food to last the day. He was referred to Disability Support who agreed to do his shopping on the following day. The officer rang to check with him and DS had carried out his shopping. He was very happy.

### Summary of issues (including benefits to citizens/service users):

In 2017, a need was identified to control and reduce various problems associated with anti-social behaviour being perpetrated in and around two footpaths, which are public rights of way, at Beverley Square, St Ann's. Concerns were raised regarding persistent and on-going anti-social behaviour caused by youths congregating on Beverley Square which had a detrimental effect on the quality of life of local residents. The anti-social behaviour was concentrated in and around two footpaths adjacent to numbers 11 and 12 Beverley Square and numbers 14 and 15 Beverley Square and was having a negative impact on the local community and surrounding area.

In order to deal with the behaviour a Public Spaces Protection Order ("PSPO") pursuant to the Antisocial Behaviour, Crime and Policing Act 2014 ("the 2014 Act") came into effect on 6<sup>th</sup> November 2017 and prohibits access to the footpaths running between numbers 11 and 12 and numbers 14 and 15 Beverley Square ('the Restricted Area') and to install barriers at either end of the footpaths.

The current PSPO will expire on 5<sup>th</sup> November 2020 and it is proposed that this Order is extended for a further three years.

Recommendation(s):

1	That, being satisfied that the test in Section 59 of the 2014 Act is met, and having regard		
	to the rights of freedom of expression and freedom of assembly, the Area Committee		
	authorise an extension to the Nottingham City Restriction of Public Rights of Way		
-			

(Beverley Square, St Ann's) Public Spaces Protection Order 2017 for a further three years from 5 November 2020.

3. In the event that a decision is made to extend the Order under recommendation (1) above, the Area Committee authorise the Director of Community Protection to carry out the necessary advertisements and arrange for appropriate signage to be erected where necessary in accordance with the legislative requirements.

#### 1. Reasons for recommendations

- 1.1 On 12<sup>th</sup> September 2017 the Dales, Mapperley & St Ann's Area Committee approved the making of a Public Spaces Protection Order ("PSPO") for Beverley Square ("the Order") which came into force on 6<sup>th</sup> November 2017
- 1.2 The Order (copy attached at Appendix 1) includes the following restrictions:
  - No person shall proceed on foot, pedal cycle, horse or in a vehicle or cause any animal to proceed in the Restricted Area during the times specified in Schedule 2 to this Order
- 1.3 PSPOs can only be in effect for a maximum of three years, and the Order expires on 5<sup>th</sup> November 2020.
- 1.4 Under section 60(2) of the Anti-social Behaviour, Crime and Policing Act 2014 (2the 2014 Act") the Order can be extended for up to three years if, before the Order is due to expire, the local authority that made the Order is satisfied on reasonable grounds that doing so is necessary to prevent
  - a) The occurrence or recurrence after that time of activities identified in the Order; or
  - b) An increase in the frequency or seriousness of those activities after that time.
- 1.5 Section 60(2) of the 2014 Act confirms that an extension under section 60 of the 2014 Act may not be for a period of more than three years.
- 1.6 Section 72 of the 2014 Act also applies, which contains provisions relating to convention rights, consultation, publicity and notification requirements.
- 1.7 On 12<sup>th</sup> February 2020 the Director of Community Protection authorised the formal consultation on the proposal to extend the effect of the Order for a further three years from 5<sup>th</sup> November 2019
- 1.8 The penalty for committing an offence contained in a PSPO is a maximum fine of level 3 on the standard scale (currently £1,000) although the opportunity to pay a fixed penalty may be offered instead. In the event that a decision is made to extend the Order, fixed penalties for offences in breach of the Order will continue to be £70, with a reduction to £35 if paid within ten days.
- 1.9 The proposed extension to the Order is not intended to interfere with responsible persons frequenting the area to use the shops available or to interfere with local tenants and residents using the area.

#### 2 Background (including outcome of consultation)

2.1 For a number of years concerns have been raised by local residents regarding persistent and on-going anti-social behaviour around Beverley Square, which has had a detrimental effect on the quality of life of local residents. From the evidence and other relevant information gathered from local residents and other sources, the anti-social behaviour appeared to be concentrated in and around two footpaths running between numbers 11 and 12 Beverley Square and numbers 14 and 15 Beverley Square. The footpaths have "flying bedrooms" above them and these design characteristics mean that the footpaths are

sheltered from the weather, partly concealed from passive surveillance and were therefore an ideal environment for carrying out the anti-social behaviour and other reported incidents.

- 2.2 The unreasonable conduct was reported to be persistent in its nature and was causing harassment, alarm and distress; evidence showed that these issues impacted greatly on the quality of life for the residents, visitors and businesses alike through intimidation. This undoubtedly was having a detrimental effect on the quality of life of those in the locality,
- 2.3 Evidence to date indicates that the Order has been very effective in deterring the above behaviour
- 2.4 Concerns have been raised with both Nottinghamshire Police and Nottingham City Council's Community Protection Service that if the Order were to lapse, the behaviours described above may restart and the problems may reoccur resulting in further anti-social behaviour once more in an area that has been provided respite as a result of the actions taken by the City Council. It is therefore proposed that the Order be extended for a further period of three years to provide a continuation of the respite.
- 2.5 Consultation on the proposed extension of the Order commenced during the 24<sup>th</sup> February 2020 and concluded on 22<sup>nd</sup> March 2020 however an additional two weeks were given to those occupants of properties abutting the alleyway.
- 2.6 The Council has consulted with:
  - The Chief of Police, the local policing body, and the Police and Crime Commissioner for the police area that includes the restricted area. However, the Council have not received a response.
  - The owner or occupiers of land within the restricted area.
  - The Council published a copy of the Order on its website and explained that it proposed to extend the effect of the Order for a further three years.
  - Neighbourhood Development Officers have been made aware of the proposals.
  - A consultation letter and questionnaire in the form attached at Appendix 3 were discussed with all residents in the locality of the Restricted Area where possible, otherwise posted through their letterboxes.
- 2.7 The consultation ended on 22 March 2020 and it is recognised that four months have passed since the formal consultation ended. I can confirm however that there have been no further comments received in relation to the proposal to extend the Order since the consultation ended and no other issues have been raised.
- 2.8 It had been intended to take this report to the June Area Committee but due to the Covid-19 pandemic and the resultant 'lockdown' resulting in June's Area Committee being cancelled, this report is being brought forward to the first available committee. Since the consultation period ended the Council has not received any further communications regarding the proposed extension, or the PSPO generally and therefore the recommendations remain unchanged.
- 2.9 As a result of evidence collated during the consultation period, there appears to be support for the proposed extension to the Order. The Council has not received any responses to the consultation however anecdotal evidence from residents in the locality suggests that there continues to be support for the pathway to be gated off.
- 2.10 It is considered that the restrictions/prohibitions being sought to continue are proportionate, necessary and reasonable.
- 2.11 The Council must be satisfied that the proposed extension to the Order meets the test contained in section 60(2) of the 2014 Act detailed at paragraph 1.4 above, and they must have particular regard to the rights of freedom of expression and freedom of assembly set out in Articles 10 and 11 of the Human Roughts Convention.

- 2.12 In addition, if the extension to the current Order is made, the extended Order will be published on the Council's website and signage to confirm the extension will be placed in the Restricted Area in accordance with the statutory provisions, together with the existing signage that advises of the prohibitions contained in the Order, and that breach of the Order is a criminal offence. These will continue to act as a deterrent.
- 2.13 Once the extension to the PSPO on Beverley Square has been approved, there will be no on-going financial implications. The costs of enforcing the Order will be met within the existing roles of the Community Protection Officers, Police Officers and Police Community Support Officers.
- 2.14 The cost of any additional signage and advertisement in accordance with the legal requirements will be taken from Community Protection's budget but it is expected to be well under £100.

#### 3. Other options considered in making recommendations

3.1 If allowed to end, the gates that have been placed to prohibit access to the footpaths would have to be removed. The Council and the Police would no longer have the powers to take enforcement action to tackle the behaviours described above under the Order and the Council is of the opinion that it is likely that the behaviours will begin to reoccur and Beverley Square will start to suffer anti-social behaviour again.

#### 4. Finance colleague comments (including implications and value for money/VAT)

4.1 The financial implications in respect of this decision are minimal. There will a cost in relation to new signage following this decision (estimated to be less than £100). This cost can be contained within approved resources within the Community Protection Directorate.

## 5. Legal and procurement colleague comments (including risk management issues, and legal, crime and disorder act and procurement implications)

- 5.1 The power to extend the Order falls within the remit of this Area Committee and the proposal appears to be in accordance with the Council's Scheme of Delegations.
- 5.2 As identified in the main body of the Report, PSPOs should only be extended where the Council is satisfied on reasonable grounds, that the legal test in section 60(2) of the 2014 Act is met in relation to all of the areas that the Order applies to.
- 5.3 When deciding whether to extend the Order the Council must have particular regard to the Rights of Freedom of Expression and Freedom of Assembly set out in Articles 10 and 11 of the Convention (as provided by section 72(1) of the 2014 Act).
- 5.4 As identified in the main body of the Report, the Council has undertaken a consultation exercise regarding the proposed extension to the Order, which appears to be in compliance with the requirements in the 2014 Act and Statutory Guidance.
- 5.5 The Council should also consider how easy the Order, if extended, will be to enforce, since failure to properly enforce an Order could undermine the effect of an Order. The gates, currently in place to prohibit access to the Restricted Area will remain in place and will continue to support the Order's enforcement.
- 5.6 It is proposed that, if extended, the Order will last for a further period of three years. Under section 60(2) of the 2014 Act there is provision for the PSPO to be extended for a further period of up to three years at the end of that extended period. There is no restriction on the number of times that a PSPO can be extended. As identified in the body of the Report the Council must comply with publication and signage requirements

  - (a) that Anti-Social Behaviour including urinating, verbal abuse, depositing human excrement, dog excrement, congregating, fighting, littering and damage to property has had
    - (i) a detrimental effect on the quality of life of those in the locality of the Restricted Area, and
    - (ii) is likely to continue to an unreasonable extent, rendering the prohibitions imposed by this Order justifiable, and
  - (b) having considered the likely effect of making this Order on the occupiers of premises adjoining or adjacent to the Restricted Area and where the Restricted Area constitutes a through route having considered the availability of a reasonably convenient alternative route



- 4. Save as provided in Article 6 below, no person shall proceed on foot, pedal cycle, horse or in a vehicle or cause any animal to proceed in the Restricted Area during the times specified in Schedule 2 to this Order.
- 5. A barrier or barriers may be installed by the Authority for the purpose of enforcing the restrictions provided for in this Order and the contact details of the persons who are respectively responsible for maintaining and operating the barrier or barriers are given at Schedules 3 and 4 to this Order.
- 6. Nothing in Article 4 shall apply to the following:
  - (a) the personnel of the Ambulance/National Health Services, Fire and Rescue Services or Police proceeding in the Restricted Area;
  - (b) occupiers of premises and the invitees and licensees of occupiers of premises in adjoining or adjacent to the Restricted Area who require access to or egress from such premises;
  - (c) where the Restricted Area is the only or principal means of access to premises used for business or recreational purposes, periods when the said premises are used for such purposes;
  - (d) persons carrying out any of the following operations if the vehicle being used in relation to such operations cannot be conveniently used for such purpose in any other Highway:
    - (i) building, industrial or demolition;



- (ii) the inspection, maintenance, improvement or repair of the Restricted Area;
- (e) persons carrying out any works for the laying, erection, alteration, inspection or repair of any sewer, main, pipe or apparatus in, on, under or adjacent to the Restricted Area in connection with the supply of gas, water, electricity or Electronic Communications Works;
- (f) the service for the collection of refuse or other items from premises adjacent to or adjoining the Restricted Area;
- (g) persons entering the Restricted Area with the express permission or on the direction of an Authorised Officer of the Authority or with the express permission or on the direction of the Housing Patch Manager.
- 7. The alternative routes which are available for use by pedestrians during the hours of operation of this Order are described in Schedule 5 to this Order and shown by the bold black broken lines on the Plan.
- 8. A person who fails without reasonable excuse to comply with Article 4 of this Order commits an offence and is liable on summary conviction to a fine not exceeding level 3 on the standard scale.
- 9. A person does not commit an offence under this Order by failing to comply with a prohibition or requirement that the Authority did not have power to include in the Order.

## Summary of issues (including benefits to citizens/service users):

The Orders detailed in the title to this Report were made under section 129A of the Highways Act 1980 ('HA') and were originally known as 'Gating Orders', and are now Public Spaces Protection Orders (PSPOs).

Each of the above Orders prohibits access to land as detailed in that Order and shown on the plans attached to the Orders (Restricted Areas). Each Order authorised the installation of barriers at each entrance to the Restricted Areas to enforce the restrictions. Those barriers remain in situ at the time of writing this report.

The Orders will expire on 19 October 2020 and the barriers will need to be removed if the Orders are not first extended. It is proposed that the Orders are extended for a further three years.

Recommendation(s): 1 That, being satisfied that the test in Section §9 of the 2014 Act is met, and having regard

to the rights of freedom of expression and freedom of assembly, the Area Committee authorise an extension to the Nottingham City Council (Candle Meadow, Colwick Park, Nottingham) Gating Order 2008 for a further three years from 19 October 2020. 2. That, being satisfied that the test in Section 59 of the 2014 Act is met, and having regard to the rights of freedom of expression and freedom of assembly, the Area Committee authorise an extension to the Nottingham City Council (Kilnwood Close, Carlton, Nottingham) Gating Order 2009 for a further three years from 19 October 2020. ### 1. Reasons for recommendations

necessary in accordance with the legislative requirements.

- 1.1 On 8 January 2008 the St Anns and Dales Area Committee approved the making of the Nottingham City Council (Candle Meadow, Colwick Park, Nottingham) Gating Order 2008 (GO 5003), a copy of which is attached as Appendix 1. The Order prohibits access to land to the rear between Number 15 and Number 25 Candle Meadow as shown on the plan attached to the Order ('Restricted Area 1').
- 1.2 On 28 January 2009 the St Anns and Dales Area Committee approved the making of the Nottingham City Council (Kilnwood Close, Carlton, Nottingham) Gating Order 2009 (GO 5005), a copy of which is attached as Appendix 2, prohibits access to land between Kilnwood Close and Bowland Close as shown on the plan attached to the Order ('Restricted Area 2')
- 1.3 On 20 September 2011 the Mapperley & Sherwood Area Committee approved the making of the Nottingham City Council (Botany Avenue to Ransom Road, Mapperley, Nottingham) Gating Order (GO 5009), a copy of which is attached as Appendix 3, prohibits access to land between Botany Avenue and Ransom Road as shown on the plan attached to the Order ('Restricted Area 3')
- 1.4 The above Orders were made under section 129A of the Highways Act 1980 to address issues of anti-social behaviour identified in Restricted Areas 1 3. The Orders are subject to limited exceptions, and also authorised the installation of barriers at each entrance to Restricted Areas 1 3 for the purposes of enforcing the restrictions. Those barriers remain in situ at the time of writing this report.
- 1.5 Section 129A Highways Act has now been repealed. Under section 75(1)(A) of the Anti-Social Behaviour, Crime and Policing Act 2014 ('the 2014 Act') any orders made under section 129A HA bef Dage 64 October 2014 remained in force until 20

October 2017. Under section 75(3) of the 2014 Act, if still in force at that time they continued to remain in force as if the provisions of the order were provisions of a Public Spaces Protection Order ("PSPO") made under the 2014 Act with 'any necessary modifications'. Therefore, from 20 October 2017 the Orders effectively became PSPOs.

- 1.6 However, unlike Gating Orders which were not time limited, a PSPO may not have effect for a period of more than 3 years, unless extended under section 60 of the 2014 Act. The Orders will therefore expire on 19 October 2020, and the barriers at each entrance to the Restricted Areas will no longer be authorised and will need to be removed, unless the Orders are first extended.
- 1.7 Since the Orders were made there has been a significant reduction in the anti-social behaviour reported in the localities of Restricted Areas 1 3. However, if the Orders were allowed to expire, which would result in the above mentioned barriers being removed, this may result in the recurrence of the identified anti-social behaviours in these locations.
- 1.8 Under section 60 (2) of the 2014 Act the Orders can be extended for up to three years if, before the Orders are due to expire, the Council is satisfied on reasonable grounds that doing so is necessary to prevent the –

(a) Occurrence or recurrence after that time of the activities identified in the Orders, or

- (b) An increase in the frequency or seriousness of those activities after that time.
- 1.9 Section 72 of the 2014 Act also applies, which contains provisions relating to convention rights, consultation, publicity and notification requirements.
- 1.10 This report seeks authority for an extension to the Orders for a further 3 years.

## 2. Background (including outcomes of consultation)

- 2.1 When considering whether to extend a PSPO the Council must have particular regard to the rights of Freedom of Expression and Freedom of Assembly set out in Articles 10 and 11 of the Convention. Under section 72(4) of the 2014 Act the Council must also consult with
  - (a) The Chief Officer of police and the local policing body for the police area that includes the restricted area
  - (b) Whatever community representatives the local authority thinks it appropriate to consult and
  - (c) The owner or occupier of land within the restricted area.
- 2.2 On 12th February 2020 the Director of Community Protection authorised the formal consultation on the proposal to extend the Orders for a further three years from 19th October 2020.
- 2.3 The Council has consulted with the Chief Constable, Nottinghamshire Police, and the Nottinghamshire Police and Crime Commissioner.
- 2.4 The Council has made Neighbourhood Development Officers aware of the formal consultation and sought confirmation as to whether there are any relevant community representatives in any of the three localities of the Orders.

2.5 The Council has written to the occupier of each of the properties which abut Restricted Areas 1 - 3 making them aware of the formal consultation. These are:

Candle Meadow, Colwick Park - 15-25 Candle Meadow (odds) and 17 Colwick Park Close Kilnwood Close, Carlton – 28 Kilnwood Close and 654-658 Carlton Road. Botany Avenue to Ransom Road – 14-30 Abbey Grove, 17-34 St Ann's Gardens and 3-11 (odds), 21, 23, 29, 31 45 and 47 Botany Avenue

- 2.6 The Council must also publicise the proposed extension proposals on the Council's website. The Council has published a copy of the Orders on its website and explained that it proposed to extend the effect of the Orders for a further three years. Attached to this report at Appendices 1, 2 and 3 are copies of the three Orders.
- 2.7 Evidence to date indicates that the Orders have been effective in deterring antisocial behaviour.
- 2.8 Concerns have been raised with Nottingham City Council's Community Protection Service that if the Orders were to lapse, the behaviours described above may restart and the problems may reoccur resulting in further anti-social behaviour once more in an area that has been provided respite as a result of the actions taken by the Council. It is therefore proposed that the Orders be extended for a further period of three years to provide a continuation of the respite.
- 2.9 Formal consultation on the proposed extension of the Orders commenced during the period 24 February 2020 and concluded on 22 March 2020. An additional two weeks was allowed to take account of any late responses.
- 2.10 The consultation ended on 22 March 2020. There have been no further comments received in relation to the proposal to extend each of the Orders since the consultations ended and no other issues have been raised.
- 2.11 It had been intended to take this report to the June Area Committee but due to the Covid-19 situation and June's Area Committee being cancelled that this report is being taken to the next available committee. Since the consultation period ended the Council has not received any further communications regarding the proposed extensions, or the PSPOs generally and therefore the recommendations remain unchanged.
- 2.12 There were no letters received in response to the consultation on any of the three Orders. Two e mails supporting the extension of the Candle Meadow order were received. One of the responses was from a Candle Meadow resident who stated "These gates have been a godsend and should never be removed". Two e mails were received in respect of the Botany Avenue order. One was in favour of the renewal and one against. The objection was around the lack of access to the rear of their property in order to carry out boundary repairs. Despite requesting access to the gates key holder they had not been granted access. The objector stated that if they could get access then they would withdraw their opposition. This issue has been taken up by Community Protection to try and resolve. It should also be noted that the restrictions in the Orders do not apply to 'occupiers of premises and the invitees and licensees of occupiers of premises adjoining or adjacent to the Highway', and therefore access by the objector for the reason they describe is not prohibited.

- 2.13 It is considered that the restrictions/prohibitions being sought to continue are proportionate, necessary and reasonable.
- 2.14 The Council must be satisfied that the proposed extension to each of the Orders meets the test contained in section 60(2) of the 2014 Act detailed at paragraph 1.8 above, and they must have particular regard to the rights of freedom of expression and freedom of assembly set out in Articles 10 and 11 of the Human Rights Convention.
- 2.15 In addition, if the extension to the Orders is made, the extended Orders will be published on the Council's website and signage to confirm the extension will be placed in the Restricted Areas in accordance with the statutory provisions and the existing signage that advises of the prohibitions contained in the Orders will be amended to refer to the extension. These will continue to act as a deterrent.
- 2.16 The cost of signage is estimated to be well under £100.00 in total for all three Orders and will met from Community Protection budgets.

### 3. Other options considered in making recommendations

3.1 If the Orders are allowed to end, the gates that have been placed to prohibit access to the footpaths would have to be removed. The Council and the Police would no longer have the powers to take enforcement action to tackle the behaviours described in the original Gating Orders and the Council is of the opinion that it is likely that the behaviours will begin to reoccur and that users of the footpaths and those living in the vicinity will start to suffer increased anti-social behaviour again.

## 4. Finance colleague comments (including implications and value for money/VAT)

4.1 The financial implications in respect of this decision are minimal. There will a cost in relation to new signage following this decision (estimated to be less than £100). This cost can be contained within approved resources within the Community Protection Directorate.

## 5. Legal and Procurement colleague comments (including risk management issues, and legal, Crime and Disorder Act and procurement implications)

- 5.1 The power to extend the Orders falls within the remit of this Area Committee and the proposal appears to be in accordance with the Council's Scheme of Delegations.
- 5.2 As identified in the main body of the Report, PSPOs should only be extended where the Council is satisfied on reasonable grounds, that the legal test in section 60(2) of the 2014 Act is met in relation to all of the areas that the Orders apply to.
- 5.3 When deciding whether to extend the Orders the Council must have particular regard to the rights of freedom of expression and freedom of assembly set out in articles 10 and 11 of the Convention (as provided by section 72(1) of the 2014 Act).
- 5.4 As identified in the main body of the Report, the Council has undertaken a consultation exercise regarding the proposed extension to the Orders, which

appears to be in compliance with the requirements in the 2014 Act and Statutory Guidance.

- 5.5 The Council should also consider how easy the Orders, if extended, will be to enforce, since failure to properly enforce an Order could undermine the effect of an Order. The gates, currently in place to prohibit access to the Restricted Areas will remain in place and will continue to support the Order's enforcement.
- 5.6 It is proposed that, if extended, the Orders will last for a further period of three years. Under section 60(2) of the 2014 Act there is provision for a PSPO to be extended for a further period of up to three years at the end of that extended period. There is no restriction on the number of times that a PSPO can be extended. As identified in the body of the report the Council must comply with publication and signage requirements

7.1 The extension of the Orders will not adversely affect any particular group of citizens. Under the Council's Fair and Just Nottingham Equity Scheme, the proposed extension of the Orders comply with the underlying principles of the scheme and promotes fair and individual enforcement based on the Orders. The extension of the Orders may have originally impacted on those who are disabled through limiting their access to adjoining roads meaning that they may have had to travel longer distances. However Restricted Areas 1 - 3 have all remained gated off for at least eight years and the Council has received no concerns from residents. Therefore there will be no additional adverse impact on disabled citizens that has not been in place for over eight years.







#### **1** Reasons for Recommendations

- 1.1 The Nottingham LTP strategy 2011-2026 maintains a commitment to deliver local transport improvements across Nottingham's neighbourhoods and prioritises small-scale transport improvements of importance to local communities.
- 1.2 As part of the budget process Nottingham City Council approved at the Executive Board meeting on 18 February 2020 an LTP capital allocation of £1.25 million citywide between 2019 -20 was approved. At the same meeting a citywide allocation of General Fund Element (public realm) of £750,000 was agreed. At the subsequent Executive Board meeting on 21 July 2020, as part of the budget update, a top-slice of 20% was made to the General Fund Element (public realm) reducing it to £600,000. Page 107

# 2 Background (including outcomes of consultation)

- 2.1 The Area Capital Programme was established to improve the environment of the neighbourhoods and to create a sense of place for residents in order to improve the quality of life of local people. Since its establishment in 2006 to meet the then corporate priority of 'Transforming Neighbourhoods', the Area Capital Fund has included a total programme expenditure portfolio of £40 million. The improvements that have been carried out to date using the programme have included footpath construction and repairs, fences, visual enhancements to public realm, refurbishment of parks and improvements to public buildings.
- 2.2 Resources are allocated from the Nottingham City council general fund, the Local Transport Plan (LTP) and from the Housing Revenue Account. To achieve a joint approach to environmental improvements in neighbourhoods, a greater degree of flexibility has been established to prioritise and deliver improvements so that there is a synergy in local solutions for local issues across neighbourhoods.
- 2.3 The programme of works is a rolling programme. There have been instances where schemes are started, with strong community involvement and interest, only to be altered at a later stage due to changing circumstances such as economic conditions and changes in land values.
- 2.4 The Area Committee, particularly community representatives, are invited to comment specifically on those schemes identified in the proposals column and to consider whether certain schemes can be linked to other programmes of work in order to generate best value and create a greater impact on the local area.
