35 Workplace Parking Charge increase

Nigel Hallam, Workplace Parking Levy Service Manager, presented the report, which detailed proposed increases in the Workplace Parking Charge City and Neighbourhood rates (a full list of the current and proposed charges for each was contained within the report).

Resolved to approve an increase, effective from 01 April 2021, to the:

- 1) Workplace Parking Charge City rates by 0.9%, in line with the annual Workplace Parking Levy Retail Price Index increase;**

- 2) **Workplace Parking Charge Neighbourhood rate from 1.28% to 1.29%, in line with 0.9% annual Workplace Parking Levy Retail Price Index increase.**
