Reasons for the Decision(s)	An agreement for lease is in place on the property and one of the conditions is the Council, as landlord, undertake works to repair and refurbish the property, including ensuring the sprinkler system is in full working order.
	Following initial repair works it was established that the pump serving the sprinkler system is in need of significant repair. In addition the system must be pressure tested the water tank fully cleaned out and the pump re fueled.
	These and some other small works are required for the Council to comply with the obligation of the agreement for lease.
