#### BACKGROUND

- The Nottingham Funeral package has been available since the mid 1990's and during this time has ensured that a low cost affordable funeral service is available to the residents of Nottingham City.
- Over recent years the take up of the Nottingham Funeral has gradually increased to an average of around 400 per year.
- Any bookings made for this type of Funeral package automatically come to the Cemetery Service for the funeral to take place which in turn helps to ensure continued business to our service.
- Currently Nottingham City residents or those who have lived in the City within the last 3 years who have since moved for care purposes can qualify for this package.

#### **CURRENT SITUATION**

- The current contract expires on the 1<sup>st</sup> July 2021
- Colleagues from the Cemetery Service, Legal and procurement sections are working together to formulate a new City of Nottingham Funeral concession that ensures a continued competitively priced service is available subject to a new tender process.
