4. Glossary of Terms

Term	Description
Looked After Children	Children or young people (aged under 18 years old) in the care of a local authority or provided with accommodation by the authority for more than 24 hours. This includes unaccompanied asylum seeking children, children in friends and family placements, and those children placed for adoption but not yet adopted.
Care Leavers	Young people who are Looked After Children, who are aged 18 and leaving the care system.
Placement	The accommodation/setting where the Looked After Child is placed. This could be with a foster family, in a children's home (residential home), or another type of placement.
Supported Lodgings	A type of placement which can be provided to older children in care or care leavers, who are making steps towards independence. Supported Lodgings are provided in a family or 'host' home in the community. The host provides a room and cooking and washing facilities, as well as offering some support and advice to the young person - the young person effectively becomes a lodger in the host home. Nottingham City Council does not currently have a Supported Lodgings offer.
Staying Put	Enables young people to stay in their foster care placement after their 18 th birthday. This option can bring a good deal of stability to the young person particularly if still in education.

5. Summary

(Please provide a brief description of proposal / policy / service being assessed)

It is proposed that Nottingham City Council work with children’s charity Barnardos, to develop and run a pilot Supported Lodgings scheme in Nottingham, utilising legacy funding which has been gifted to Barnardos’.

The Supported Lodgings scheme will require a project officer to recruit and assess potential hosts. These hosts will provide accommodation and support to Children In Care / Care Leavers aged 17 and over. The proposal is for Barnardos to fund the costs of the project worker for one year to implement the scheme and recruit up to 10 hosts. Nottingham City will pay for the cost of the placements. (This will be at a significantly lower cost than other appropriate placement options). Referrals will be made to Nottingham City’s Placement Service based on need, decided by panel as per the usual processes for identifying suitable placements. There will be no obligation for Nottingham City Council to utilise this supported lodgings accommodation should it not be suitable for the young people currently requiring placements.

The pilot will be evaluated after a year to assess the effectiveness and efficiency of the scheme. A formal decision will then be required to determine whether to continue to provide Supported Lodgings.

their families. Young people in foster care may have the option of 'staying put' but this is not appropriate in all cases. A Supported Lodgings scheme would create an additional option for young people, which would give them the opportunity to live with a degree of independence appropriate to their age, in a host home. They would be able to seek advice and support from their hosts as required, as would be expected for a young person of their age. This is likely to lead to improved long term outcomes for young people as they leave care and live independently.

8. Arrangements for future monitoring of equality impact of this proposal / policy / service:

The pilot scheme will be managed via a contract, initially in place for 1 year. Monitoring requirements will be built into this contract to ensure it can be evaluated effectively at the end of this year. Monitoring will include outcomes for the young person. During the term of the contract, it will be monitored against agreed outcomes by Nottingham City Council's Contracting team, on a regular basis, (likely to be quarterly but to be agreed).

Towards the end of the contract the scheme will be evaluated to determine impact on outcomes for the

young person, and value for money.

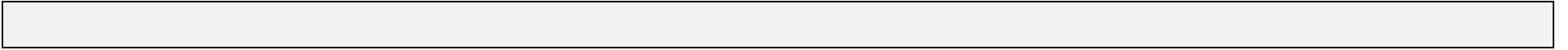
