To accept funding from the National Trust of £45,000 to deliver the Blossom Again Project as detailed in Appendix 1

To delegate the authority to the Director of Neighbourhood Services to enter into any procurement or contracts relating to the delivery of this project.

Reasons for the Decision(s)

This project aims to plant Blossom Trees around the country to remember people who have passed away due to Covid-19. The funding would be split across 2 different park sites in Nottingham. The National Trust are working with select partners across the country to achieve this objective. Nottingham City Council would receive funding to enhance park areas and plant more trees. Our aim is to plant 50,000 trees by 2023 as part of our Corporate priority and also to assist us in delivering our Carbon Neutral Strategy priorities by 2028.

Appendix One

National Trust Blossom Again Project

The National Trust and Nottingham City Council are working in partnership with a view to planting trees at 2 different sites for the Blossom Again project.

Nottingham would be 1 of 4 or 5 places to be involved in this project.

The Blossom Again idea is to embed Covid-19 into the Nation's Cultural memory and to help nature and people to blossom.

The project aim is to select sites around the City that would benefit from a Blossom Circle, Avenue or other profile. Community and Stakeholder engagement will be key to selecting the site, shape of Blossom and establishing a connection with this project.

Out of several sites Lenton Recreation Ground and St Mary's Rest Garden have been shortlisted for this project as it is felt these sites will most benefit the community and enhance the locations.

Funding for this project will be provided by the National Trust and will be £45,000. With £40,000 being allocated at the start of the project and £5,000 being provided in Spring 2022 to promote the completion of the projects and for community engagement.

Volunteers will be engaged for ongoing maintenance and care of the trees and a watering programme will be implemented for the trees for the first 3 years as we would our newly planted trees.

Planting trees is crucial for Nottingham City Council achieving its 50,000 tree planting target and assisting us in being carbon neutral by 2028.

Lenton Park Recreation Ground is currently used by students who play football on the grass using studded boots. There are signs placed on site to discourage the wearing of studded boots as this is destroying the grass but it continues. The introduction of the Blossom Project at Lenton Park Recreation Ground is designed to break

up the area in phase 1. Subject to funding, in phase 2 it is proposed to create a multi-use games area so football activity can be moved to another part of the park.

The aim of the project is to allow people to reflect on the impact of Covid and remember those who we have lost to this disease.
