Grant Award Agreement: Bus capacity work

I am writing to you to set out the details of the second tranche of the Local Transport Authority Bus Capacity (Revenue) Funding allocation.

Thank you for letting us know that your authority has published a notification of intent for an Enhanced Partnership Scheme (EPS) and/or bus franchising. It is encouraging to see that all LTAs are engaging with the Bus Back Better strategy, and we look forward to working with you to support the development of your Bus Service Improvement Plan and the delivery of these plans.

We have now released the second tranche of this grant to those LTAs that have committed to an EPS and/or franchising, except Combined Authorities that are already in receipt of City Region Sustainable Transport Settlement (CRSTS) capacity support. ICTS capacity funding was inclusive of funding to support bus reform plans, as set out in the Chief Secretary's letter to those authorities.

The value of the grant awards to each LTA are shown in the annex.

Purpose of this Grant

The purpose of this grant is to support LTAs in developing local bus proposals as outlined in the National Bus Strategy (NBS) and is being offered to help LTAs towards the development of their EPS or franchising scheme, and Bus Service Improvement Plans (BSIP) work, and to meet the timescales that go alongside that work. It is non-legally binding, as required in Section 31 grants.

Grant Details

This grant is additional to the flat rate £100k that we allocated to every LTA in the first tranche of bus capacity funding. The grant amounts for the second tranche of funding have been based on LTA population and Indices of Multiple Deprivation. This is to reflect

the scale of the issues across LTA areas, and the fact that buses are relied upon more by residents in deprived areas. However, we did set a minimum grant of £50k to ensure that all LTAs had additional support to develop their plans.

The grant is being paid based on the understanding that LTAs need additional capacity and capability support to progress their plans on buses as outlined above. The grant covers revenue expenditure for activities relating to these plans, as outlined in the NBS and any subsequent guidance from the Department.

The Department anticipates that this funding will be used for:

- recruitment of additional LTA staff to undertake the work required;
- procurement of consultants to support the work required;
- training of new and existing staff to boost their capabilities on relevant bus policy and delivery; and
- other activities to support the development of LTA bus plans.

LTAs should consider how they can use their funding efficiently and avoid duplication of effort. For instance, LTAs could work within their sub-national transport body (STB) to pool some of their capacity funding with other authorities to address common issues or to coordinate work with bus operator partners at a wider geography. Or to work with neighbouring LTAs to address cross-boundary solutions across wider travel to work areas.

The Department has an aim to see the development of in-house capabilities on bus issues across all LTAs. LTAs should take this into account when using this capacity funding. Where consultants are used, the LTA should endeavour to include knowledge exchange as part of the consultancy process. The NBS included a commitment to develop a Bus Centre of Excellence to help tackle the longer-term development of bus capabilities in LTAs and bus operators. We plan to say more about that in the near future.

We intend to contact LTAs in due course to collect information on how this funding (both tranches of funding) have been spent (or will be spent), as well as any other information to enable the Department to evaluate bus capacity issues in LTAs. It is important for DfT to understand how the funding for capacity and capability has been used to inform our future thinking on capacity support.

Should circumstances change and the LTA no longer has need for the funding, or a part of the funding, to undertake the work above, they should contact the Department to arrange reimbursement (at the email address below).

LOCAL TRANSPORT AUTHORITY BUS CAPACITY (REVENUE) GRANT DETERMINATION 2021-22: No 31/5650.

The Minister of State for Transport ("the Minister of State"), in exercise of the powers conferred by section 31 of the Local Government Act 2003, makes the following determination:

Citation

1) This determination may be cited as the Local Transport Authority Bus Capacity Grant Determination (2021-22) [No 31/5650].

Purpose of the grant

2) The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them.

Determination

3) The Minister of State determines as the authorities to which grant is to be paid and the amount of grant to be paid.

Treasury consent

4) Before making this determination in relation to local authorities in England, the Minister of State obtained the consent of the Treasury.
