substance misuse services

Decision Being Taken:

- 1) To seek approval for the receipt of funding from Department for Work and Pensions (DWP), managed by Public Health England (PHE), for the provision of Individual Placement and Support (IPS) for employment support among the population in substance misuse treatment.
- 2) To seek approval for dispensation from Contract Procedure Rule 4.1.2 in accordance with Financial Regulation 3.29 to award funding to an existing service (Framework) that delivers similar interventions.
- 3) To seek approval to delegate signing authority to the Director of Commissioning and Procurement for any contract variations that arise from this process.

Public Health England, as a result of a successful pilot in some areas across other local authority areas, opened up an expression of Reasons for the Decision(s) interest for remaining funding to other local authorities across the country. The funding offered to Nottingham City (£220,000) must be used for the provision of Individual Placement and Support (IPS) support for adults who are accessing drug and alcohol support services, and that require tailored and intensive support to access employment. IPS is intensive employment support delivered by trained employment specialists and provided as part of multi-disciplinary clinical services, rather than separately through mainstream employment support services. The funding must be used to employ one senior employment specialist and two employment specialists who will work along with other professionals from a variety of services, but most specifically drug and alcohol treatment workers who will be responsible for identifying suitable service users to work with the IPS team. The funding will be awarded with the requirement that the money is spent by 31st March 2023. The funding will be allocated to deliver an IPS provision alongside the requirements detailed in the service specification for the integrated drug and alcohol treatment service currently provided by Framework (Nottingham Recovery Network). It is widely accepted that a person is more likely to achieve recovery if they have stability in other areas of their lives; one of the pivotal factors is obtaining and maintaining employment. It can contribute to a person's self-esteem, perceived self-worth and can improve overall mental wellbeing, in addition to providing an income. Dame Carol Black's most recent research paper identifies employment as an essential element of a person's recovery from drug misuse and/or dependency. Appendix 1. Rejecting the funding available for this provision will deny Nottingham City the opportunity to gain additional income from external sources, and ultimately stop the improvement of outcomes for citizens. 2) Procure the provision through a competitive process. The tight timeframes set by Pubic Health England mean that a tender process would not allow for deadlines to be met in terms of outcome requirements attached to the funding. The Crime and Drugs Partnership is the lead commissioner for substance misuse services in the City, and has robust performance management arrangements in place for these services. As employment is a vital element of recovery, it contributes to the fulfilment of the CDP's annual priorities.

Legal Advice:

There are no legal issues with the Council accepting receipt of funding as this will be covered under the general power of competence and the Localism Act 2011.

With regard to the dispensation and award of the additional services to Framework regard needs to be had to Financial Regulation 3.29 which currently permits the Chief Finance Officer and Portfolio Holder to grant a dispensation for operational reasons. The reasons have been set out in the report with regard to the delivery of the service and the use of the funding. The decision maker must be satisfied that the reasons are sufficient so as not to conduct a tender process as would be required for a contract of this value under Contract Procedure Rule 4.1.2. In addition, and as per the comments from the Procurement advisor, this would be a permitted modification under the Public Contracts Regulations 2015 (as amended).

In addition to being satisfied that there are operational reasons for the dispensation the decision maker must be satisfied that the award of the additional services without a separate procurement process demonstrates Best Value in accordance with s.3(1) Local Government Act 1999 and a continuing improvement of the Council's functions in respect of economy, efficiency and effectiveness.

Finance Advice:

This decision seeks approval for the receipt of funding from Department for Work and Pensions (DWP), managed by Public Health England (PHE), for the provision of Individual Placement and Support (IPS) for employment support among the population in substance misuse treatment.

Funding of £0.220m will be received in line with the payment schedule attached to this decision, which states £0.083m will be received in financial year 2021/22 and £0.137m in 22/23. Funding must be spent by 31st March 2023 and NCC should manage receipt of this funding in line with the schedule to ensure all funding is claimed in a timely manner and accounted for correctly across the respective financial years. Funding should be spent in accordance with any grant requirements.

Dispensation from Contract Procedure Rule 4.1.2 in accordance with Financial Regulation 3.29 to award funding to an existing service (Framework) that delivers similar interventions is sought. Procurement of the service through a competitive process was discounted due to the tight timeframes set by Pubic Health England which means that a tender process would not allow for deadlines to be met in terms of outcome requirements attached to the funding.

Procurement Advice:

This decision relates to the receipt of funding of £220,000 from Department for Work and Pensions (DWP), managed by Public Health England (PHE), for the provision of Individual Placement and Support (IPS) for employment support among the population in substance misuse treatment. Dispensation from Contract Procedure Rule 4.1.2 in accordance with Financial Regulation 3.29 (operational issues) for this funding to be added to the current contract with Framework Housing Association as part of the Integrated Drug and Alcohol Treatment Service contract as detailed in Appendix 1.
