#### 2. Assessment

##### 1. Brief description of proposal / policy / service being assessed

The second round of the Home Office Safer Streets Fund (2021-2022) provided funding to hotspot areas within England and Wales that are disproportionately affected by neighbourhood and acquisitive crime, to invest in evidence-based situational crime prevention interventions such as home security and street lighting. For the purposes of the Fund, neighbourhood crime is defined as burglary, robbery, theft from the person and vehicle crime. In March 2021 the Office of the Police and Crime Commissioner (OPCC), submitted a bid, in partnership with Nottingham City Council and Nottinghamshire Police, focused on three lower super output areas within the Hyson Green & Arboretum and Radford wards. These were identified as within the largest hotspots for the in-scope crime types in the city, outside of the city centre, that is for burglary, robbery and theft from the person and vehicle crime.

The bid was successful and the OPCC was awarded £432,000 to undertake the work described in the bid, the primary focus of which was burglary reduction and prevention, with the main tactic being target hardening. This involves providing vulnerable properties and citizens with target hardening materials such as alarms, locks, lighting and other devices and also fitting these materials. Alongside this engagement with vulnerable groups will be used to drive positive behavioural change, such as not leaving properties unlocked or otherwise insecure.

The programme runs from August 2021 until the end of March 2022. The OPCC allocated the City Council £40,753 of the Home Office Safer Streets funding, which is for the following:

1. £37,220 of the funding is to pay the staffing costs of a temporary Burglary Reduction Officer post within Resident Services until March 2022.
2. £3,533 was allocated for the supply, installation and connection of pole mounted CCTV camera, at Bridlington Park in Hyson Green

### **2. Information used to analyse the effects on equality:**

The bid focusses on the Arboretum and Radford areas of Nottingham, as the areas with the largest hotspots for the in-scope crime types in the city outside of the city centre. The three LSOAs are coterminous and have a combined population of fewer than 9,000. The in-scope offence types of burglary, robbery, vehicle crime and theft clearly cluster in two main areas, the city centre and our selected intervention areas. The selected areas have a consistently higher level of serious acquisition crime than other areas in the city.

The city undertakes an annual statistically significant survey of crime and ASB. In this area, citizens consistently identify burglary as their greatest crime concern which is the case for both under 24 and over 24 year olds. The Radford and Hyson Green & Arboretum wards have they first and third highest survey scores respectively for people believing “crime is a very or quite big problem in their area”. These results have been broadly consistent across the life of the survey since 2011.

This area of the city is an area dominated by houses of multiple occupancy (HMOs), occupied by both students (especially in LSOA E01033404) and by transitory and highly diverse populations, which as a consequence presents challenges to crime reduction where relationships with policing and partners are by their nature more temporary as well as providing barriers to communication and engagement. The local authority describes the area:

*“Census data since 2001 indicates high levels of ethnic diversity within both Hyson Green & Arboretum and Radford, with significant minorities of Pakistani and Caribbean ethnicities living alongside majority White British populations. In the interim, inward migrations of EU nationals (in particular Eastern Europeans), Roma groups, and other ethnicities (including mixed, which were recorded for the first time at the 2001 census) have balanced demographics in both areas closer to a 50/50 split between White British and other ethnicities, including Non-White British.*

*These shifts reflect factors which are characteristic of both wards as densely populated inner city areas (e.g. high density, low rents, prevalence of social housing, high unemployment/ deprivation, etc); they are 'landing zones' for inwardly migrating groups which subsequently become socially mobile (as seen with Polish migrants across the period, and particularly since EU accession in 2004, for example).*

*Meanwhile, between the 2001 and 2011 Censuses, full-time student populations in Nottingham practically doubled (from around 20,000 to 40,000); current estimates suggest the total has since increased by similar volumes, and is now closer to 65,000." Nottingham City Council Cohesion Service 2021*

**How different groups could be affected**

Due to the make-up of the area (set out in Q2 above), it is likely that the project will have a particular impact on younger people and on people from BAME groups.

It is estimated the Safer Streets 2 funding will support the following over the period of the project:

- 500 properties within the Safer Streets 2 areas will be risk assessed through the work of the Burglary Reduction Officer and will have target hardening burglary reduction measures installed
- 375 student properties within the Safer Streets 2 area will be risk assessed through the work of the Burglary Reduction Office and will have video ring doorbells installed

The CCTV camera installed at Bridlington Park in Hyson Green will monitor the park area, helping to reduce crime there and improve residents' feelings of safety. Referrals will be made from the Control Room to Police for follow up as required.

- A comprehensive performance management framework has been set up across the whole of the Safer Streets 2 project. Data on protected characteristics is being collected by the BRO when risk assessments and target hardening are carried out.
- The impact of the project as a whole is being monitored and baseline crime figures have been established.
- Detailed SMART performance monitoring against key and clearly defined performance indicators will be collected monthly from each element of the project, including monitoring of the protected characteristics. Progress against targets will be analysed monthly and actions taken to address any improvements required in performance.
- Key milestones for the delivery of the service have been agreed and risks identified and these will also be monitored monthly and action taken to improve if required.
- Measuring against performance indicators and milestones will allow us to measure the extent to which the project is delivering and to take action to improve as required.
