Decision Being Taken:	To accept DLUHC Statutory Duty Grant funding of up to £566,169 and delegate authority to the Corporate Director for Communities,			
	Environment and Resident Services to enter into the Grant Agreement. To delegate authority to the Corporate Director for			
	Communities, Environment and Resident Services to spend up to £566,169 to award contracts and make variations between April 2023			
	and March 2024 on the purposes specified in appendix 1 in compliance with the councils contract procedural rules.			
Reasons for the Decision(s)	The Domestic Abuse			
	Act 2021 places a statutory duty on Tier 1 local authorities as of 1 April			
	2021. The DLUHC grant will enable Nottingham City Council to fulfil the functions of			
	the statutory duty on Tier 1 Local authorities relating to the provision of			
	support to survivors of domestic violence and abuse and their children residing			
	within safe accommodation. In Oct 2022 CPEC approved the development of a DSVA /VAWG Framework to compliantly procure services.			
	However the Framework has proved more complex than anticipated as it has to be agreed across the commissioning partnership. Subsequently the Framework has been delayed until 2023/24 and therefore a decision is required to spend the DLUHC Grant on services			
	for one year in 2023/24 whilst the Framework is concluded. The funding on which approval is requested totals			
	£566,169 All the contracts are to deliver the Statutory Duty for the Local Authority, as set out in the Strategy and Needs			
	Assessment submitted to DLUHC. The suppliers recommended are the only suitable suppliers to deliver best value in this interim			
	period. The proposed contracts will be in compliance with the councils contract procedural rules.

Finance Advice:	This report seeks approval to accept and spend £566,169 of the Department of Levelling Up, Housing and Communities (DLUHC) statutory grant funding award from 1st April 2023 to 31st March 2024. The grant funding will be received into the Communities, Environment and Resident Services Department of the Crime and Drugs Partnership (CDP).
	The grant will enable Nottingham City Council to fulfil the Community Based Service functions of the statutory duty on Tier 1 Local authorities relating to the provision of support to survivors of domestic violence and abuse and their children residing within safe accommodation (as set out in Part 4 of the Domestic Abuse Act 2021).
	Detailed allocation of spend against this grant is set out in the appendix within this report.
	The Council must ensure all spend is within the terms and conditions of the grant and that no future financial risk is committed to beyond the current funding agreement. All spend must be closely monitored ensuring value for money and in accordance with internal process controls whilst remaining within the grant allocation amount, ensuring no MTFP financial pressures materialise.

Procurement Advice:	This decision relates to the receipt and expenditure of grant funding from the Department of Levelling Up, Housing and Communities (DLUHC) for the delivery statutory duties under the Domestic Abuse Act 2021. It proposes contract awards and variations to extend existing contracts (as detailed in Appendix 1) for the delivery of community based services during 2023-24.		
	The proposed contract awards will enable the Council to fulfil its obligations under the statutory duty pending the establishment of a framework of providers of these services for awards from April 2024 onwards. The Procurement Team has been consulted on these proposals. In relation to the proposed awards to Juno Women's Aid for specialist posts, exemption has been approved from the procedural requirements of the Contract Procedure Rules in accordance with Article 18.79. The proposed award to Equation is considered to be a permissible extension of an existing contract.		
	A number of awards will be made through a quotation process in compliance with the Contract Procedure Rules. The commissioning process to establish a framework of providers for these services should be completed in a timely way during 2023 to enable the compliant award of contracts from April 2024.

### 5. Summary

(Please provide a brief description of proposal / policy / service being assessed)

The Domestic Abuse Bill due to become legislation in April 2021 includes a Statutory Duty for Local Authorities to commission Domestic Abuse services (accommodation based). MHCLG has allocated Nottingham City Council with £871,229 to fund DVA services for one year. The allocation in 2022 will be based on the spend of this allocation in 2021.

DSVA services are commissioned by the Crime and Drugs Partnership on behalf of commissioning partners through a formal Partnership Agreement between Nottingham City Council (including Public Health), Office of the Police and Crime Commissioner and the Clinical Commissioning Group. The partnership function is delivered by the DSVA Joint Commissioning Group which makes recommendations to the CDP Board and to the City Council Commissioning and Procurement Subcommittee as required.

The contracts to deliver the Statutory Duty will be initially for one year, as that is the funding allocation by the MHCLG. Other elements of the new Statutory Duty include an annual Needs Assessment and Survivor Engagement, this will be progressed during 2021 and will support future decision making on the following years MHCLG funding allocation.

The findings and recommendations from this EIA will be used to determine the equality requirements of the service specification, and any additional considerations for the procurement process.
