Review of the Council's designated polling places under the provisions of the Representation of the People Act 1983, (as amended). Due to a number of polling places no longer being available and new accessibility requirements a review of existing places as been conducted. Assessment and consideration of the reasonable needs of the electorate and, in particular, the needs of disabled people are prescribed under the statutory review process. The designation of polling places must seek to ensure that all electors have such reasonable facilities for voting as are practicable and seek to ensure that so far as is reasonable and practicable the polling places are accessible to those who are disabled. Equality considerations have been integral to the review process.

Information has been obtained directly from the premises requesting information about the accessibility arrangements, to ensure they are fully accessible and for those that are not a site visit has been conducted.
