Reasons for the Decision(s)	Department for Energy Security and Net Zero (DESNZ) will launch the project in March and waiting for the Executive Board to sign off the decision will cause the Midlands Net Zero hub to miss out on the funding. The next Executive Board meeting is expected to be in May, therefore delaying the governance process by at least two months leading to funding for the project to be withdrawn. Through the Energy Security Strategy, DESNZ committed that "by summer we will launch a comprehensive energy advice service on GOV.UK which will help consumers navigate what can be unknown territory to improve the energy performance of their homes. We will launch additional support for homeowners through telephone support and specific local area advice for energy consumers. "This funding will be specifically for the element referred to as 'local area advice for energy consumers' and will be managed by the Midlands Net Zero Hub, within the Environment and Sustainability directorate enabling the provision of in person support for citizens be developed and undertaken in support of the cost of living crisis. The total Grant allocation will be worth £4,440,000, of which £440,000 will be allocated to the Hub and the Environment and Sustainability directorate to design, deliver and monitor the competition. The Hub is well-placed to do this, and it will generate revenue for the Council and create jobs across the region. This work also aligns with the D2N2 Local Enterprise Partnership's Energy Strategy and Nottingham City Council Fuel Poverty Strategy and the Councils Carbon Neutral 2028 ambitions. DESNZ has designed the funding programme to be a regional competition for funding lead by the net zero hubs. For The Midlands region the Midlands Net Zero Hub within Nottingham City Council will host the competition on behalf of DESNZ for allocation of the grant funding. DESNZ has approved a marking criterion for competition bidders against the competition guidance to
	be provided by the Department for Energy Security and Net Zero. Qualifying bids will then go to a national panel lead by DESNZ.
Other Options Considered:	Not to accept the funding: Without MNZH support, there could be a significant missed opportunity to bring the provision of energy advice into Nottingham and the wider Midlands region to address the fuel poverty and domestic decarbonisation issues for homeowners and landlords. This would also be a missed opportunity for Nottingham City Council to gain the management fund.

Person Consulted: The Chair of Overview and Scrutiny Committee Consultation Date: 12/04/2023 The need for this exemption arises due to time constraints imposed by the funding provider, The Department for Energy Security and Net Zero (DESNZ). In order to meet the funding provider's timeframe, we require the LKD to be signed off as soon as possible so that a Memorandum of Understanding (MoU) can be signed with DESNZ by Friday, April 14th. It is crucial that we meet this deadline, as failure to do so may result in the loss of funding for Midlands Net Zero Hub. Therefore, we kindly request that an exception be made to the standard call-in period to facilitate the timely signing of the LKD and MoU.

Legal Advice:	Nottingham City Council (NCC)has been allocated grant funding from DESNZ to undertake a competition on their behalf (which will be advertised on social media and the Midlands Net Zero Hub website) under which interested parties can apply for grant funding which will then be used by the successful applicants (the "Grant Recipients") to deliver the projects. In addition, BEIS has allocated NCC grant funding in the sum of £440,000 for the purpose of administering the competition and monitoring the activities of Grant Recipients. If any persons are engaged by NCC to undertake these specific roles using BEIS grant funding, they must only be engaged by NCC to undertake work on the BEIS grant funded activities. HR Advice:	The proposal is to accept and spend a grant allocation of £4,440,000 from the Department for Energy security and Net Zero to support regional delivery of Local Energy Advice (LEA) through the Midlands Net Zero Hub (MNZH).
	In order to deliver the energy advice service the service area need to recruit 1 Principal Officer post and 1 Project Officer on a 2 year fixed term contract. The posts should have an established job description and evaluated and graded accordingly, if not yet done already. Decisions on pay must adhere to NCC's pay policy and established grading scheme.
	Any necessary recruitment for temporary contracts must be in line with agreed recruitment processes and principles. It will also be necessary to liaise with the Departmental HR team to establish if each post is a potentially suitable alternative for any individuals on the Redeployment register.
	Management should ensure that value for money is considered prior to each post being filled and the Council is not incurring unnecessary expenditure.
	Management will also need to consider the exit strategy at the end of the fixed term contracts. This will need to include consideration of financial costs for potential compensatory payments for redundancy
