HOMELESSNESS PREVENTION GRANT TOP -UP 2022-23:

GRANT DETERMINATION (2022-2023) [No. 31/6399]

I write further to the Homelessness Prevention Grant Determination letter of April 2022 and the December 2022 announcement of a £50 million top-up to the Homelessness Prevention Grant for 2021/22 to support councils to help prevent vulnerable households from becoming homeless and manage local homelessness pressures

I am pleased to inform you that the Department is now able to issue a Grant Determination for this a **Winter Top Up payment for the Homelessness Prevention Grant programme** ring-fenced for 2022/2023.

I enclose a Determination made under section 31 of the Local Government Act 2003. The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred, or to be incurred, by them in maximising prevention of homelessness activities and reducing reliance upon temporary accommodation.

Earlier intervention to prevent homelessness is more effective and better value for money than waiting for households to become homeless. We expect you to use this funding to maximise upstream homelessness prevention to stop vulnerable households from becoming homeless, as well as helping to meet temporary accommodation costs where necessary.

REVENUE Grant Determination (Ring-Fenced) Homelessness Prevention Grant Top Up (2022/23): No 31/6399.

The Minister of State for Housing ("the Minister of State"), in exercise of the powers conferred by section 31 of the Local Government Act 2003, makes the following determination:

Citation

1) This Determination may be cited as **Homelessness Prevention Grant Tranche 2 Determination** 2022/23 [No31/6399].

Purpose of the grant

- 2) The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them in supporting local authorities to discharge their homelessness duties under homelessness legislation. The grant is ringfenced for 2022-2023 and is to be spent in adherence with the following principles:
 - 1. To fully enforce the Homelessness Reduction Act and contribute to ending rough sleeping by increasing activity to prevent single homelessness.
 - 2. Reduce family temporary accommodation numbers through maximising family homelessness prevention and reduce the use of unsuitable B&Bs for families.
 - 3. Ensure service financial viability of services by contributing to the costs of statutory duties, including implementing the Homelessness Reduction Act and supporting with the costs of temporary accommodation.

Determination

3) The Minister of State determines as the authorities to which grant is to be paid and the amount of grant to be paid, the authorities and the amounts set out in Annex B.

Grant conditions

4) Pursuant to section 31(3) and 31(4) of the Local Government Act 2003, the Minister of State determines that the grant will be paid subject to the conditions in Annex A.

Treasury consent

5) Before making this determination in relation to local authorities in England, the Minister of State obtained the consent of the Treasury.

Annex A

GRANT CONDITIONS

- 1. The Section 151 Officer or equivalent of each of the recipient authorities are required to sign and return to HomelessnessPolicy@levellingup.gov.uk at the Department for Levelling Up, Housing and Communities a declaration, to be received no later than 10th April 2023 in the following terms:
 - "To the best of our knowledge and belief, and having carried out appropriate investigations and checks, in our opinion, in all significant respects, the conditions attached to Homelessness Prevention Grant 2022-2023 No.31/6399 have been complied with".
- 2. The purpose of the grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them in supporting local authorities to discharge their homelessness duties under homelessness legislation. The grant is ringfenced for financial year 2022-2023 and is to be spent in adherence with the following principles:
 - To fully enforce the Homelessness Reduction Act and contribute to ending rough sleeping by increasing activity to prevent single homelessness.
 - Reduce family temporary accommodation numbers through maximising family homelessness prevention and reduce the use of unsuitable B&Bs for families.
 - Ensure service financial viability of services by contributing to the costs of statutory duties, including implementing the Homelessness Reduction Act and supporting with the costs of temporary accommodation.
- 3. The authority agrees to produce and agree a B&B elimination plan with their HAST Adviser at any time during the funding period should they have more than 5 families in B&B accommodation for longer than 6 weeks and should they be requested to do so.
- 4. If an authority fails to comply with any of the conditions and requirements of paragraphs 1 to 3, the Minister of State may
 - a) reduce, suspend or withhold grant; or
 - b) by notification in writing to the authority, require the repayment of the whole or any part of the grant.
- 5. Any sum notified by the Minister of State under paragraph 4(b) shall immediately become repayable to the Minister.
