Decision Being Taken:

(1) To commence a procurement process for a 2 year contract, plus the option of 2 further years, to supply and deliver polythene / polypropylene refuse bags and sacks. (2) Further competition to be held under the terms of the ESPO framework 860 22, Refuse and Recycling Products, Lot 10 Supply of Plastic Refuse Sacks. (3) To delegate authority to Director of Resident Services to award the outcome and sign the contract with the chosen provider

Reasons for the Decision(s) (1) Contract to supply and deliver polythene / polypropylene refuse bags and sacks as requested from stakeholders across NCC and NCH to meet business needs. (2) Procurement exercise to ensure applicable regulations adhered to - Council's own contract procedure rules and Public Contract Regulations.

(1) Do nothing - continue to raise ad-hoc orders with various suppliers at time of demand.
