 To approve the direct award of the contract for provision of technical indexes to Nottingham City Council to IHS Markit for a further 3-year period; To delegated to the Head of the IT Service authority to award and enter into this contract. 	

Reasons for Decision and Background Information

The requirement for access to technical indexes, collections of standards used in the construction industry, has existed for many years. The development of quality management systems and increasing levels of regulation in the construction industry has meant that greater levels of reference materials need to be available to professionals and craft workers. In the past these documents were provided as 'hard copy' reference materials. However, as technology has developed, particularly Internet technology, it has become more practical to offer these reference materials as online documents. This makes the standards more accessible and more easily kept up to date.

The exemption from conducting a regular procurement exercise is required because there are no other suppliers on the market that have been identified who offer as complete a service as the current supplier, IHS Markit.

Other Options Considered and why these were rejected

The option to operate without access to technical indexes was rejected as it is considered that reference to such materials is necessary to deliver effective engineering services in support of the Council's services to citizens. The option of reverting to manual indexes was rejected because these are more difficult to access than on-line materials and more difficult to maintain.

Reasons why this decision is classified as operational

The use of online technical indexes is already an operational feature of the Council and so this decision represents no change to policy and enables existing methods of working to be maintained.

Additional Information

Financial advice:

This decision aims to approve the direct award for the provision of technical indexes to IHS Markit for a further 3-year period. The contract will commence from 1st May 2023, and annual cost has been identified as Year 1, £27,798.12, Year 2, £28,910.4 and Year 3, £30,066.44, which will be paid from N-10011-100-4091. No Finance Objections.

This System has been procured in line with the Contract Procedure Rules. Due to the limited suppliers on the market, a desk top exercise concluded that IHS Markit was the only provider able to provide the full set of requirements/ technical standards needed by the service areas. Therefore, an exemption from CPRs was sought and agreed to enable a direct award to IHS Markit. Therefore, I have no procurement concerns.
