| Decision Being Taken: | 1. Approval for the Director of Sport, Culture & Tourism and team to undertake a tender process to secure a provider to deliver an annual 2 day music festival at Wollaton Park for the period 2024-2028; |
| | 2. Give delegated authority to the Director of Sport, Culture & Tourism to appoint a preferred supplier, following an evaluation of any tenders received; |
| | 3. Give delegated authority to the Director of Sport, Culture & Tourism to enter into a contract for a period of 5 years. |

| Reasons for the Decision(s) | Nottingham City Council and local promoter DHP Family have staged the annual Splendour music festival jointly since 2008. Splendour has been targeted predominantly at Nottingham residents, with a diverse line-up suitable for an all-ages audience. |
| | The concept of the event was originally conceived and developed between the Council and DHP under annually agreed terms. Due to the turnover value of the event this has been identified as a concession and under the Council's procurement policy and best value now requires a formal tendering process to be undertaken. |

| Other Options Considered: | 1. Continue with the current arrangement with DHP delivering the event - This is non compliant with current procurement regulations in relation to concessions and doesn't give the opportunity to test whether the arrangement provides best value to the Council and residents; |

| | 2. Cease hosting Splendour from 2024 - Splendour is a very popular event in the annual programme for Nottingham and brings profile, economic and social benefit for the city, which would be lost or put at risk if the event was discontinued; |
| | 3. Deliver the event in-house - This would result in potential costs and risks to the Council. The event would still require supplier contracts, the securing of artists, and a significant investment and resource requirement which there is no budget or capacity with the current team to undertake. This option is therefore not considered to represent best value. The approach to secure an external provider reflects changes in the Council's risk appetite and approach in staging large events to reduce the financial risks and begin to move towards a cost neutral, commercial income events model. |
