Decision Taken

To provide support to NCC in three areas of activity that are key underpinnings of organisation transformation

- 1. **Establishment Control:** Leading on work to provide an agreed establishment across Nottingham City Council and support on developing processes to maintain that establishment. This work will determine the true baseline position for transformation. It will focus on two key areas:
 - Continuing the roll out of the establishment baseline reconciliation across council departments
 - Developing and rolling out a simple dashboard to support budget holders with establishment reporting and monitoring.
- Continued development and implementation of the Strategic Core
 of the council. This work will build on, and commence the
 implementation of, the high level One Council operating model design.
 This work will bring together five sub-functions: the Chief Executive
 Office, Policy and Strategy, Transformation Office; Communications and
 Engagement; and Business Insight. The new function will
 - o Enable best value to be assessed and delivered across NCC
 - Support and enable wider transformation across Nottingham City Council, by maximising NCC's ability to deliver key corporate capabilities
- 3. **Core team support-** This team will continue to work directly within the Transformation Office to provide oversight to the workstreams set out in

this work order an provide additional, flexible support to other Council led workstreams to facilitate the achievement of agreed milestones e.g. financial savings.

Reasons for Decision and Background Information

This activity will ensure delivery and assurance of savings included in the Medium Term Financial Plan and delivery of the Together for Nottingham Plan.

Other Options Considered and why these were rejected

Do not procure this service – this will impact on delivery as alternative resourcing and appropriate capability is not available internally.

Reasons why this decision is classified as operational

It involves resources for the delivery of programmes in the council transformation portfolio, as part of the 2023/24 council budget.

Additional Information

The appropriate procurement process has been undertaken via the CCAS framework and aligns to the Strategic Delivery Partner report approved at Executive Board on 19 July 2022.

Finance comments

The commission of this PWC Phase 2 contract directly supports the IAB instructions, finance improvement plan and improvement activity.
