Total Value: £400,000 over 3 years (May 2023 - May 2026) (Type: Capital and Revenue)

1. To approve the Neighbourhood Bin replacement programme using a combination of Streets for People (291,000) funding and also Service areas' budget (£35,000 per year over 3 years).2. To delegate authority to the Director of Resident Services to undertake appropriate and commercially minded procurement exercise.3. We are proposing to award a year long (2023/2024) one off contract under the ESPO framework to spend the grant funding (£291,000) the following years, we will undertake a similar process to better manage demands and fluctuations in the market for the remaining (£35,000 per year - this will include cost of raw materials and labour)

Reasons for the Decision(s)

Some of our current bin stock have come to the end of their shelf life. The Bin replacement Programme will offer Best Value as replacing the end of life bins now means the new bins will serve the Residents of Nottingham for longer and give our City a new refreshed look. The new style 240L bins helps us progress towards CN28 as this will massively reduce the use of plastic bags used in bins as these style of bins do not require the use of bin bags to hold the rubbish.

Other Options Considered:

Option 1 - Not replace the end of end of shelf life bins - This option has been rejected because these bins are past tehri best and in need of replacement. Some of these bins pose a Health and Safety hazard to residents and staff. Option 2 - Replace the bin with "smart bins"-This option has been rejected because the style will not complement the urban design of our Neighbourhoods and this will not fit in with the Service Operating offer.
