Decision Being Taken:

- 1. To approve acceptance of the National Lottery Fund (NLHF) Community Fund grant of £200,000 for capital improvements to Victoria Embankment Paddling Pool.
- 2. To approve acceptance of the NLHF Community Fund grant of £50,000 for revenue funds towards the delivery of an activity plan for the site post completion of the capital works.
- 3. To approve an in year externally funded extension to the capital programme.
- 4. To delegate authority to the Director of Residents Services to continue with the procurement of the design and build and enter into contracts relating to project.

Reasons for the Decision(s) The new 25-year Green Space Strategy - Greener, Healthier, Happier is now in its final phase of production. The strategy will provide a strategic action plan to help guide the improvement of environmental practices and will seek to contribute to other city priorities such as mitigating climate change, increasing biodiversity, creating nature-rich active travel corridors, and it will help drive up the quality of our green spaces and it will improve the health and wellbeing of our residents. As part of the strategy, prioritised ward based green space investment plans have been produced.

> The project detailed within this report has been identified as strategic green space ward-based priority. The paddling pool has for many years been in need of investment and in recent years the facility has had to be closed due to failure in the pumping system and pool infrastructure. The public response clearly identified support / demand for its improvement and reopening. During the summer months, the value of an outdoor water-based facility has been clearly demonstrated particularly during long periods of dry and extremely hot weather. This has also been exaggerated by the cost of living crisis as many families have stayed at home during the summer holidays and many would have visited the paddling pool if it was not closed. Such a facility is likely to draw people from a wider area than just the Meadows and instead from across Nottingham given that there are no other similar facilities in the city.

Local consultation was carried out during the summer 2022. The consultation confirmed overwhelming support for a replacement paddling pool facility.

This evidence of need has been used to help secure £250,000 additional funding from the National Lottery Heritage Fund as per attached table. £200,000 to be allocated to the Capital build and £50,000 to be set aside to complete an activity programme at the site over a 5 year period.

Other Options Considered:

The decision to apply for this external funding was taken to enable the best possible water play experience to be provided to replace the currently closed paddling pool.

Not to accept the NLHF Funding. The paddling pool has been identified as a priority project. This option has been rejected as the funding has been allocated to Nottingham for the purpose of improving the City's heritage by re-opening the paddling pool. Having received confirmation from the NLHF of grant funding to help with this scheme there is potentially a reputational element to not accepting this grant

# Legal Advice:

This report seeks approval to accept £200,000 NHLF capital funding, £50,000 NHLF Revenue funding and to continue relevant procurement processes required by the project.

In using the NLHF funding, the Council must comply with any terms and conditions imposed by NLHF, spend capital and revenue funding appropriately and ensure funds are spent in accordance with the bid details.

As the procurement processes are described as continuing, it is assumed that delegations to the Director of Resident Services are already in place. If so, it is unclear why there needs to be further delegations as part of this decision? In any event, the delegations must be in accordance with the Council's constitution. Any procurement process needs to comply with the Public Contract Regulations 2015 and the Council's own constitution.

Prior to entering into contracts, the Council should ensure appropriate legal advice is provided either by Legal Services or sourced through Legal Services at cost where Legal Services is unable to provide the specific support required due to the specialist nature of the work.

### Finance Advice:

The proposed decision raises no financial issues, will be grant funding of £200k and £50k of Budget spread over 5 years. As it is grant funding, service area need to ensure spending is in adherence to grant regulations.

Following approval of this decision the £50k grant will be recognised within revenue while the £200k capital grant from the NLHF will be added to the current approved scheme within the capital programme. This amendment to the capital programme has been endorsed by the capital board.

Due to current financial pressures within the Capital Programme should the amended project budget of £744k be insufficient the scheme is required to be value engineered and / or additional third party funding to be identified to cover any funding pressures.

The project manager is required to ensure that the grant condition for the revenue and capital elements of the grant are complied with to reduce the risk of grant clawback.
