**Decision Being Taken:** 

1. To accept up to £357,517 from the Youth Endowment Fund via the Office of the Police and Crime Commissioner (OPCC) and District/County Councils to fund posts and travel for additional resource within the Slavery Exploitation Team to deliver the Another Way Project from 2023-2025.2. To delegate authority to the Head of Community Safety to recruit and spend the £357,517 on staff salaries (354,443 including management costs) and travel (£3,074) within the Slavery Exploitation Team to deliver the Another Way Project from 2023-2025. The funding is as set out in the funding letter dated 10th July 2023 from the OPCC - attached.3. To delegate authority to the Corporate Director of Communities and Resident Services to enter into the appropriate grant agreement.

Reasons for the Decision(s) The Nottinghamshire OPCC has provided confirmation of funding for 2023-2025 for the Slavery Exploitation Team to deliver the Another Way Project. Another Way is a violence reduction project targeted at young people aged 14-24 years. The project is limited to those who live in the city of Nottingham and are seen to be at risk of violence - both as victims or offenders - due to associating with a group or gang or being exploited by a gang, for example through County Lines. It will start in 2023 and run to summer 2025. Funding will cover 20% of the team's existing manager, full salaries (including on costs) of a Senior Caseworker, 2 Caseworkers and travel expenses. These are new temporary posts within the Slavery Exploitation Team structure; contracts will end in summer 2025. Another Way will use focused deterrence, an approach to reducing group violence that originated in the USA but has been tried in various forms in the UK. In summary it:- Identifies a group or groups involved in violence- Works with local communities to gain support and assistance with the programme- Offers support to group members to change behaviour - Where groups or their members don't comply, they are the subject of robust enforcementWork with under 18s will be will be led by the council's Early Help and Youth Justice Service. A separate decsision has been completed for this. The Slavery Exploitation Team will lead on supporting adults 18-24 years of age with additional support from community organisations. Help will be provided for people involved in violence to access positive support and social services. The funding breakdown is in the attached table. The Youth Endowment Fund have indicated funding can roll forward, with approval from them, but it would be a local Project Board decision as to whether or not any underspend rolled forward is allocated to the same budget heading.

1. Not accept the funding for these posts within the Slavery Exploitation Team from the OPCC. This would mean the council would not be able to deliver the Another Way project.2. Do nothing and not fund the posts, meaning key community safety work will not be carried out.
