Decision Being Taken:	1. To accept up to £523,401 from the Office of the Police and Crime Commissioner (OPCC) and District/County Councils to fund posts and travel for additional resource within the Slavery Exploitation Team to deliver the service county-wide from 2023-2025. The Proposal and expansion budget is attached.2 . In addition to accepting the income from the OPCC and County colleagues, there is a cost to Nottingham City Council of £36,833 (£10,833 for Nov 2023 - March 2024 and £26,000 for next financial year). Additional pressures will be met by a Public Health and Asylum Dispersal Grant, and further income from the Another Way Project. This will mean for every £1 we are investing as a city, we are accepting £14 to deliver public services and improve safeguarding outcomes.3. To delegate authority to the Head of Community Safety to recruit and spend the £523,401 on staff salaries and travel within the Slavery Exploitation Team to deliver the service county-wide from 2023-2025. The funding is as set out in the attached Draft Partnership Agreement.4. To delegate authority to the Corporate Director of Communities and Resident Services to enter into the appropriate grant agreement.

Reasons for the Decision(s)	The Nottinghamshire OPCC, Nottinghamshire County Council and Districts (Ashfield, Bassetlaw, Broxtowe, Gedling, Mansfield, Newark & Sherwood and Rushcliffe) have provided confirmation of funding for 2023-2025 for the Slavery Exploitation Team to deliver the service county-wide.Initially the intention was to start the county-wide delivery from April 2023 but changes in budget and job regrades have delayed the start and created an underspend that can cover the shortfall - see attached. The team has dedicated officers who work with partners to identify and tackle exploitation, modern slavery and trafficking and offer support to survivors. To drive a multi-agency approach, the team co-ordinates and chairs a monthly SERAC (Slavery Exploitation Risk Assessment Conference) which unites agencies to discuss known or suspected cases and plan a joint response to manage risk, safeguard victims and intervene. This increases effectiveness and co-operation between agencies, resulting in better service provision and outcomes for vulnerable citizens who have been exploited. The work of the team and SERAC naturally incorporates identifying and appropriately dealing with a number of issues affecting individuals and the wider community including serious violence, domestic abuse, sexual violence, hate crime, honour based abuse, substance use, mental health, homelessness, children's safeguarding, serious organised crime, recruitment of children and anti-social behaviour. The current model features in Local Government Association guidance on Tackling Modern Slavery as an example of best practice and the manager Chairs the LGA's National Modern Slavery. Network. The team also has representation on a Home Office First Responder Organisation Forum. The estimated cost per modern Slavery victim in the UK in 2016/17 (latest available data) was £328,720 - taken from the governments Economic and Social Cost of Modern Slavery. Some cases are referred to the SET when it is too late for early intervention or prevention and victims will fall int
