Section 1 – Equality Impact (NCC staff/ Service users/ Citizen/ Community impact)

1. a. Brief description of proposal to be assessed

Nottingham City Council reviews parking tariffs regularly to ensure that they continue to manage the highway needs with flexible, high quality customer services which meet the ongoing and evolving market demands for parking within the city centre. Key to these reviews is the need to be flexible in the use of parking provision through duration and price. As part of this process, it is proposed to make changes to the Council's parking tariffs.

We are proposing to alter the Council's parking tariffs to continue to meet the evolving market demands such as the increased amount of people working from home. As per the Local Transport Plan ([LTP, 2011](#)), it is also essential that parking complements other city and transport strategies, promoting a higher turnover of vehicles throughout the city centre, thus creating capacity and fewer queues for spaces at busy times and promoting public transport as being a cost-effective alternative.

This EIA covers the following decisions: On-Street Zones 1-3 Tariff Changes and Off-Street Car Park Tariff Changes, as outlined below.

1. b. Information used to analyse the equalities implications

Traffic Management will follow the process to change the legal order by publishing a Variation Notice in the local Metro newspaper, alongside corresponding signage on-street and in the car parks notifying customers of the changes.

No formal consultation is required for a Variation Notice, however feedback can be made through the Have Your Say process. Surveys and further consultation with customers at different locations will be carried out in 2024, following the tariff alterations. Any feedback will be considered and this EIA will be updated as necessary. Annual surveys take place to quantify various groups of customers using the Council's parking facilities and on-street parking, as well as weekly and quarterly reports assessing the usage of MSCPs and Parking Services' tacit knowledge of the service area.

The proposal to change parking prices will increase parking revenue. The Road Traffic Regulation Act 1984 ([Legislation.gov.uk, 1984](https://legislation.gov.uk/ukpga/1984/18)) states that all surplus revenue from parking must be ring-fenced for public transport and highways improvements. This EIA therefore considers both the direct impact of the price change and the indirect impact of improvements to public transport and the highway as a result of the increased income.

The Traffic Management Act 2004 ([Legislation.gov.uk, 2004](https://legislation.gov.uk/ukpga/2004/17)) states that "It is the duty of a local authority... to manage their road network", including "the avoidance, elimination or reduction of road congestion". Therefore, this price change aims to reduce road congestion and this EIA considers the impact this would have on individuals.

It is recognised that improvements in congestion and air quality will benefit all citizens and visitors to Nottingham, however, this EIA has focused on areas where certain groups will be *disproportionately* impacted by the changes.
