	4-year contract, for the supply of planned and reactive maintenance and repair of cooking and catering equipment and also maintenance
	of specialised coffee equipment on behalf of Nottingham Catering (expenditure has been approved by the Spend Control Board,
	reference: 3852); 2. To delegate authority to the Director of People Services to award the contract(s) to the successful bidder depending on the outcome of the procurement exercise.
Reasons for the Decision(s)	The current contract for maintenance of catering equipment is expiring in Q1 2024 and requires to start the tendering process for the
	next contract to ensure all necessary repairs and both planned and reactive maintenance of equipment in schools and commercial
	catering locations across the City is in place. A tender process is required to ensure that best value is achieved and the standards of
	service are maintained to protect education and commercial contracts and income generation to the council. Current Coffee
	Repairs is on an Ad-Hoc basis. Nottingham City Council Catering requires a dedicated supplier ensuring machines are annually serviced, repairs are available as required. Tender will operate as either two lots. Lot 1 will be Planned and Reactive Maintenance
	of catering equipment, value of up to £125,000 per year. Lot 2 will be Planned and Reactive Maintenance of Coffee Equipment, value of
	up to £8,000 per year total £36,000 over 4 years. Alternatively this will be one main contract for the maintenance of equipment and
	as the value is smaller a separate tendering exercise for the coffee maintenance to ensure best value.
Other Options Considered:	Do nothing - This option was rejected as this would expose the Council to financial and performance risks and liabilities in regards to its
	statutory health and safety responsibilities and contractual obligations.

Nottingham Catering currently spends approximately £130,000 per annum for the supply of preventative maintenance and repair of cooking and catering equipment and maintenance of specialised coffee equipment in schools and commercial catering locations. The current contract for this service expires soon and a new tender process is required to enable the continued operation of the service.
Tender will operate as 1. Maintenance & repair of catering equipment, value of up to £125,000 per year total £500,000, 2. Maintenance of Coffee Equipment, value of up to £8,000 per year total £36,000 over 4 years £134,000 per year.
The contract will need to be reviewed after the initial 2-year period to ensure prices remain competitive and it is still fit for purpose for the service.
