Executive Summary: The Public Health team will provide a summary of the Pharmaceutical Needs Assessment supplementary statement reports issued for Q2, Q3 and Q4 2023-2024. The latest Nottingham City Pharmaceutical Needs Assessment was published in October 2022 (Pharmaceutical Needs Assessment 2022-2025). Supplementary statements are required where changes to the availability of pharmaceutical services are noted. All changes occurring within the period since the publication of the data used within the Pharmaceutical Needs Assessment are noted, irrespective of their impact on the overall accessibility of pharmaceutical services in Nottingham City. For Q2 2023-2024 a number of changes are noted: One pharmacy changed ownership, with no effect on the availability of pharmaceutical services. Seven pharmacies reported reductions to opening hours. The majority of changes result in a cessation of provision of early morning (pre 08:30) and late night (post 21:00) services. Full details can be found in the supplementary statements accompanying this report. For Q3 2023-2024 two pharmacies changed ownership, with no effect on the availability of pharmaceutical services. For Q4 2023-2024 a number of changes are noted: Three pharmacies changed ownership, with no effect on the availability of pharmaceutical services.	

One pharmacy changed location to a new premises 0.4 miles away from the previous location. The new location is accessible from the previous location in under 10 minutes by foot, or 5 minutes by car. The new premises is on a main bus route for patients using public transport.

How mental health and wellbeing is being championed in line with the Board's aspiration to give equal value to mental and physical health:

As part of the Pharmaceutical Needs Assessment, mental health is championed through a multi-faceted approach that recognises its significance and addresses the various aspects of mental wellbeing, including intelligence and data, and stakeholder and patient consultation. This allows mental health to be considered and recognised alongside physical health.
