Additional Information

The procurement of this system will be via G Cloud – Lot 2 G Cloud 13 framework, which has been discussed and agreed with NCC procurement at a meeting on the 29/11/23. Meaning we are fully compliant with our procurement regulations.

This arrangement will be formally called off from the G-Cloud Framework in compliance with the terms of the framework.

As part of the overall process IT were also engaged and stated that they were happy that the system can be introduced without concern as the information will be held in a cloud system with access via standard browser connectivity.

This means that the use of this system has been approved by procurement and IT.

The budgets to undertake this work were approved at the Executive board held in Feb 24, which included the Chief Finance Officer. The budgets are also contained within the HRA revenue accounts
