Reasons for the Decision(s)

Permission is sought to issue a framework tender for 10 Lots of Ice Cream Concessions, for a contract duration of 5 years with an option to extend for a further 3 years. The service has a successful history of hosting concessions on sites, which helps generate significant income for the City, contributing to the service's Medium Term Financial Plan (MTFP), with additional income from the concession helping improve service provision and provide better value to residents, whilst helping reduce pressures on the general fund. Working with procurement the concessions will be offered through a competitive process.

Other Options Considered:

Not tender out these concessions, This option has been rejected as it will reduce income generating potential for the sites and place additional pressures on core budgets. There will also be potential issues with ice cream vans turning up at sites without permissions. To Tender out the concessions. This option has been accepted as the best option to ensure concession holders accountability, to ensure that concession holders have secured agreements for the pitches which enables their security oftenure and greater opportunities for the concessionaires to invest in their facilities, that they have secured. This additional income will be utilised to help fund the service, reduce general fund pressure and support moves towards self funding delivery.

Advice Sought:

The report seeks approval to issue a framework tender for 10 lots of ice cream concessions. The proposal raises no significant concerns and is supported, as the council intends to go out to tender to procure the new contracts. Advice provided by Amana Parveen (Solicitor) on 16/05/2024.

Finance Advice:

The purpose of this decision is to approve the tender process of ice cream licences in various parks across the city. There are existing licences in place for some parks and this report will be opting to tender for additional lots across the city, tendering for 5-year contracts with an option to extend for a further 3 years.

The value of the decision can vary due to successful bids in the tendering process, which would be covering a 5-year period, with various increases applied. Depending on the option to extend, this value could also increase further.

The assumption around this decision would be that NCC would be successful across the 10 lots, which would result in additional income for the service, funding service expenditure and reducing the pressure on the general fund for the council, supporting the Council's MTFP. If the lots aren't successful however, then there would be no increase to the income target for the service area.

Apart from two of the ten lots, the decision would generate additional funds for service area's expenditure, working towards the service area becoming self-funding as well as contributing further towards the general fund.

Best value would be considered as the department would be tendering through the NCC procurement process, ensuring a fair and appropriate tendering process for the successful bids of the ice cream concession licences.

Once successful lots have been identified and appropriate budget adjustments have been applied, it would be the service area's responsibility to ensure that the income target is met.
