Reasons for the Decision(s)	Warm Homes funding was launched on 30th September 2024 as a competition with a closing date of 25th November 24. As a result of feedback from other energy efficiency schemes such as Local Authority Delivery (LAD) (1a, 1b, 2, 3), Home Upgrade Grant (HUG) (1, 2) Social Housing Decarbonisation Fund (SHDF) (1, 2,1), some LAs lack the capacity to submit and individual bid for funding, particularly within the required timescales. Therefore a regional submission with Midlands Net Zero Hub as the Lead Authority offers and opportunity for all LAs and Registered Providers of Social Housing (RPs) in the region to access the needed funding to support thousands of fuel poor households. The current regional delivery of domestic retrofit offers and effective route for implementation of Warm Homes Social Housing Fund across the midlands. This decision will generate and estimated £300k management fee to contribute to 25/25, 26/27 and 27/28 financial returned from the CRPP division support Medium Term Financial Plan (MTFP) projections.
Other Options Considered:	Not to submit a bid- Without MNZH support, there could be a significant missed opportunity to bring financial support into Nottingham and the wider Midlands region to address the fuel poverty and domestic decarbonisation issues within social housing

Obviously, any large grant such as the warm homes grant could use a dynamic purchasing system to commission delivery.

Finance Advice:	REVENUE COMMMENTS: This decision does not commit the Council to additional spend revenue spend, as it is dependent upon a successful grant bid. As detailed in the recommendations any additional revenue costs will require further formal approval and supporting business case.
	This decision commits the Council to submitting and accepting a grant funding bid, but not to incur any expenditure. Assuming the grant bid is successful a future decision which sets the split between ancillary / administrative cost and the capital improvement elements will be required before resources are committed.
	Prior to this project being incepted into the Capital Programme it will also require endorsement by the Capital Board as well the formal approval to incur the expenditure. Advice provided by Tom Straw (Senior Accountant - Capital Programmes) on 13/11/2024.
Procurement Advice:	There are no direct procurement concerns with the decisions being sought. Procurement of the Dynamic Purchasing Systems was agreed by Commercial Oversight Board on 21st October for an upper limit value of £1bn, though please note the committed spend at this time is nil and any tenders run through the DPS will need further approvals at point of use.
