OK, I note the position. Because of their charitable status – they are a self-funding non-profit making organisation – my clients again ask that the Council takes a lenient view on costs but, if possible, not seeking to recover abortive auction costs.

My clients are aware of the call-in the underpinning reason for which appears to be a jaundiced and prejudiced view of their spiritualist beliefs. The centre will essentially however be operated as a community facility. They will be used for the purposes of the church on Tuesday and Saturday evenings, on Friday afternoons and also on Sunday but at all other times they will be used for various community based activities including a library and social area (for knilling and board games etc), for providing daily (Monday to Saturday) breakfasts and lunches for and as a general drop in centre for the elderly and others, for the purposes of a children's creche and for exercise classes. Staffing will be provided by volunteer members of the church or the community and the premises will be available for hire by members of the community for community based activities. Also, my clients are aware that there has been talk of the need for a replacement Post Office facility and they confirm that they will examine the feasibility of providing that within the premises.

I should be grateful if you would ensure that this email is forwarded to the appropriate portfolio holder for the purposes of the call-in.
