1. BACKGROUND AND PROPOSALS

2014/15 has been a very busy year for the Youth Cabinet and its associated groups and forums.

Membership of the Youth Cabinet is drawn from young people aged between 16 and 21 from or living in Nottingham who are involved in youth projects, further and higher education, volunteering, apprenticeships or training and who wish to contribute to youth leadership activity and decision making in the city. The group currently has 16 members.

Participation in Governance programme

Participation is the active involvement of citizens in decision making. For children and young people this involvement can take place in three different settings; *individual, social* and *group*. Youth Cabinet offers opportunities for involvement in a group participation setting.

As previously reported to the Board, under the Participation in Governance programme children and young people are supported to participate in decision making in the Children's Partnership through regular events like Youth Council and Primary Parliament.

The activities of specialist forums like the Children in Care Council and the Special People Group (SEND) are also influenced by the Youth Cabinet agenda, while group members contribute to a variety of participation programmes and partnership work.

The Youth Cabinet's thematic programme of meetings, events and group work enables children and young people to participate alongside decision makers and contribute to the design, development and delivery of strategies and plans for service improvement. The programme enables partners to plan engagement and participation with various participation groups and engage larger number of children and young people through Youth Council and Primary Parliament events.

Youth Council and Primary Parliament

Youth Council is a large general meeting of young people from across the city, held once a term. Meetings are themed and involve focused activity workshops as well as activities to develop participation skills.

The themes are Education, Work and Training (Autumn term), Safe Lives and Positive Communities (Spring term), Health and Well-being (Summer term).

Primary Parliament are for Year 5 and 6 children and are organised in conjunction with the Nottingham Learning Trust. These meetings have the same thematic content and general structure as Youth Council but workshop activities are different and age appropriate.

In 2014/15:

- 120 young people took part in Youth Council meetings
- 170 children took part in Primary Parliament meetings

Topics in focus have included:

- Sexual health and relationships
- Healthy eating
- Science and technology careers
- Staying safe at home, at school and in the community
- Things to do, places to go, people to talk to

Findings from this work have fed into a wide variety of strategies, service plans and review analysis including the Child Development strategic commissioning review and Safeguarding participation planning.

Other Youth Cabinet activity in 2014/15

- Youth Cabinet members were involved in planning and delivering sessions on voting and voter registration to over 350 16-17 year olds on the National Citizenship Service
- Members have also provided bespoke training sessions to NCS.
- Support for the STEMWORKS plan launch
- Exchange visit to Newcastle Youth Council, the Centre for Life and Baltic Centre to learn about STEM engagement and develop *Sharing the Future*

Sharing the Future

Through the STEMWORKS and Early Citizen programmes Youth Cabinet has been aa key stakeholder partner in the development of a new model for citizen participation, *Sharing the* Future.

Sharing the Future has been included in our Participation Strategy and is now being used to plan and deliver citizen engagement in a wide number of settings. It has been adopted as the participation model by STEMWORKS and Early Citizen as well as by Lincolnshire County Council for their new participation strategy.

2015/16 programme

Youth Cabinet is now planning its 2015/16 programme and invites partners from the Children's partnership to engage with it to identify their participation needs and plan appropriate engagement activities.

A full programme of Youth Council and Primary Parliament events is planned to cover the three terms, in addition to regular monthly Youth Cabinet meetings.

YouConf2015

Youth Cabinet members will represent Nottingham at YouConf2015 in Karlsruhe this coming June in an event to mark Karlsruhe's 300th anniversary. Preparation work and findings from the conference will help identify further ways for young people to engage in decision making around city development issues. Engagement in this work form Board partners is welcome.
