Grant of 99 year lease to Western Power for relocation of sub station at Beechdale Baths

Total Value:

Decision Being Taken:

Decision to grant a 99 year lease for a peppercorn on a site area of approx 170 sq ft on land within the freehold curtilage of Beechdale Baths for Western Power to install a new electricity sub station.

Reasons for the Decision(s)

The Beechdale baths site and buildings are being readied for marketing in Autumn 2015 and thence onward disposal for redevelopment. There is currently a sub station comprising part of the existing building. This sub station serves the needs of Beechdale Baths and a large number of homes and businesses in the immediate environs.

The existing buildings will be demolished (either by NCC or the eventual purchaser). Thus it is necessary to re site the sub station to serve the future needs of the site itself (for redevelopment) and the wider community. This needs to happen in advance of any demolition or other redevelopment works.

Western Power are going to undertake these works free of charge but require a 99 year lease on a parcel of land. At an on site meeting 23rd June 2015 an appropriate site was agreed - see attached plan.

As the freehold interest in the whole site will be disposed of shortly it is not considered necessary to seek a shorter term income producing lease to Western Power - their providing the relocation free of charge is subject to the 99 year lease. This grant is not detrimental to the marketability of the site.

The relocation is essential for the sale of the site to be effected.

There is no scheme of delegation allowing grant of a lease interest of this kind in excess of 30 years.
