- 2) Recommend Council to consider whether the 'No Casino Resolution" should be renewed and confirm whether this should form part of the consultation

Reasons for the Decision(s)

The Council is under a Statutory Duty to adopt a new Statement of Gambling Policy to come into effect on 31 January 2016 and is under a duty to consult on the proposed Policy.

It is proposed that the outcome of the consultation process and any revisions made to the draft policy as a result are reported to Council at its meeting in November 2015 and that the Policy be formally adopted at that meeting.

Other Options Considered:

Not to recommend to Council that the Draft Statement of Licensing Policy 2016-2019 be released for consultation. This option was discounted as the policy is a statutory requirement.

Legal Advice:

The draft Statement of Gambling Policy 2016-19 has been the subject of legal advice to check its conformity with the relevant legislation and Guidance. Under the Local Authorities (Functions and Responsibilities) (England) Regulations 2000 (as amended) the production of the Policy is not the sole function of the Executive. The final Policy can only be approved by full Council and will need to be approved at the November meeting in order to comply with statutory timescales. The Council has the power to consider whether to renew its previous "No Casino" resolution which has effectively been in force since May 2007 but which will lapse with the existing Policy. If such a resolution were to be passed it would not affect the 6 premises which were already licensed as Casinos before the Gambling Act 2005 came into force. Section 175 of the Gambling Act 2005 places a statutory limit on the number of new casino licenses which can be granted nationally and the Secretary of State is required to specify which Authorities may issue those licences. Nottingham is not specified as an Authority which can grant such licenses and therfore no applications for new casino licenses could be made in any event. However, the Council can still pass a " no casino " resolution if it feels it appropriate and necessary and some possible principles to which the Council could have regard in doing so are outlined in Appendix 2 of the Draft Statement of Policy.
