Decision Being Taken:	To extend the contract for the external Project Manager engaged on the Finance improvement and Oracle Enablement programme, for a limited period and with an amended remit.
	To approve the spend associated with this decision.
Reasons for the Decision(s)	
	Although the Enablement Programme entered a new phase some weeks ago and an extension of the PM contract with the same remit is no longer necessary, there is much still to do, with many of the additional tasks having been identified by the work of
	the Programme. If the core objectives of the Enablement Programmeare to be delivered, an extension
	of the PM contract with a different remit is indicated, characterised by the gradual phasing out of this role. A further two
	month period of full time engagement is recommended, with a detailed review at the end of the first month, followed by a further two
	months of two / three days a week where the actual frequency will be decided through a review at the end of the second month.
Other Options Considered:	The great majority of the work required will be delivered by NCC resources, supported by LCC and NCH colleagues. The use of in-house
	and partner resource has, therefore, been maximised.
	The coordinated and timely completion of the remaining tasks are vital to the successful completion of the project and this indicates the requirement for experienced project management not available internally.
