Payment for Schools Out holiday provision from April 2015 to March 2016

**Total Value:** 

£85,000 (Type: Revenue)

**Decision Being Taken:** 

- 1) To approve payment of funds associated with the city's 'Schools Out' programme to the sum of £85K to Notts County Football in the Community (NCFITC) for continued provision of the programme from April 2015 until March 2016.
- 2) To approve dispensation from the requirement of Contract Procedure Rule 5.1.2 to obtain 3 tenders in accordance with the Financial Regulation 3.29, for operational reasons.

## Reasons for the Decision(s)

Schools Out runs from city leisure facilities, operating during school holidays. The programme offers 230 daily places at 5 locations, equating to 12,650 attendances per year. The scheme charges £1 a day for this provision, which supports low cost, affordable access to childcare provision, especially for working parents. The existing partnership arrangement and Big Lottery funding to NCFITC finished in March 2015. It was agreed in February 2015 that the City Council would commit to an extension and continue delivery of the offer under the existing partnership arrangement with NCFITC.

In approving this decision, continuation of service and fulfilment of the manifesto commitment of ensuring that children and young people are offered a range of positive actitivies during the school holidays as well as evenings and weekends will be ensured. Without approval service delivery of the scheme will cease to continue.

1. To have no school holiday provision. 2. The alternative option would be to go out to tender competitively for a provider to deliver the programme, however due to time constraints this is not a practical option and would cause disruption in the provision of the services when it is required most.

Legal Advice:

The 'Schools Out' programme enables affordable access to school holiday activities to children and parents in the City and in doing so has positive crime and disorder implications for the City.

The arrangement with NCFITC will ensure continued provision of this services as well as fulfilment in line with the manifesto commitment.

Should the service will delivered after this period, the Corporate Procurement Team will assist in considering future requirements with the service area.

**Finance Advice:** 

- 1. The total cost of this scheme will be £85k. This will be financed from £50k corporate contingency fund (agreed CCR0009) and £35k from permanent deletion of a vacant Sport & Leisure post.
- 2. This decision will not inhibit the service on delivering on the MTFP.
- 3. The service seeks approval for dispensation from the requirement of Contract Procedure Rule 5.1.2 to obtain 3 tenders in accordance with the Financial Regulation 3.29.

**Procurement Advice:** 

On discussion with the service area I understand that dispensation is sought from tendering in accordance with Contract Procedure Rule 5.1.2 in order to fund this service for a period of one year, to bridge a gap in direct funding to the provider by the Big Lottery. This is supported for the operational reasons set out, ie: to ensure continuity of service for this period in line with a manifesto commitment.

Any future requirement for this service which the Council intends to directly fund must be procured in accordance with Contract Procedure Rules, which at this value would require a full competitive tender process, unless a dispensation is approvied under Contract Procedure Rules.
