# REPORT OF THE LEADER

#### APPOINTMENT OF HONORARY ALDERMEN

### 1 SUMMARY

- 1.1 Provision exists within the Local Government Act 1972 to appoint Honorary Aldermen and Honorary Alderwomen, those former Councillors who, in the opinion of the Council have provided eminent service to the Council.
- 1.2 Honorary Aldermen and Honorary Alderwomen must be appointed by two thirds of Councillors voting at a specially convened Extraordinary meeting of Council.

- 5.1.1 Mohammad Aslam was elected to the Wilford ward on 4 May 1995, and then to the Lenton ward in 1997, where he served as a Councillor until May 2000. He then stood again at local elections in 2003, where he was elected to the Radford and Park ward on 1 May. He was re-elected to the Radford and Park ward in 2007, and again in 2011, and served as a Councillor until May 2015. As well as being a Councillor, he has also served as a Justice of the Peace.

- 5.2.5 Brent Charlesworth was the Sheriff of Nottingham in 1992/1993, the Deputy Lord Mayor in 2002/2003, the Lord Mayor in 2003/2004, and the Lord Mayor again in 2005/2006.

5.2.6 As Sheriff of Nottingham, he travelled to America and presented Kevin Costner with an award to recognise his achievements in promoting Nottingham through the popular motion picture Robin Hood; Prince of Thieves, and whilst serving as the Lord Mayor of Nottingham he opened the Ningbo campus of the University of Nottingham in China.

# 5.3 Honorary Alderman lan Malcolm

- 5.3.1 Ian Malcolm was elected to the Wilford ward on 4 May 1995, and re-elected to the Wilford ward in 1997. He was then elected to the Clifton West ward in 2000. In 2003 he was elected to the Clifton South ward, which he was re-elected to in 2007 and 2011. He was a Councillor for this ward until May 2015.
