



MEMORANDUM OF UNDERSTANDING

between

INSTITUTE OF VERTEBRATE OF PALEONTOLOGY AND PALEOANTHROPOLOGY

and

NOTTINGHAM CITY COUNCIL

and

THE UNIVERSITY OF NOTTINGHAM

regarding

THE FEATHERED DINOSAURS EXHIBITION

This Memorandum of Understanding records the intention of Institute of Vertebrate of Paleontology and Paleoanthropology, 142 Xi-Zhi-Men-Wai Street, Beijing 100044, China (hereinafter Party A), Nottingham City Council, Loxley House, Station Street, Nottingham, NG2 3NG (hereinafter Party B) and The University of Nottingham, University Park, Nottingham, UK, NG7 2RD (hereinafter Party C) to develop a collaboration to bring a temporary exhibition of feathered dinosaur fossils to Wollaton Hall throughout July and October 2017.

Party A will:

- a) Identify the exhibits for the exhibition from their collection
- b) Ship the exhibits to arrive at Wollaton Hall at a date to be determined but no later than 20th June 2017
- c) Assemble and install the delivered exhibits at Wollaton Hall (CIF)
- d) Ensure all relevant Licences are in place
- e) Be responsible for the identification of guest speakers
- f) Be responsible for staff and guest speaker visas
- g) Provide access to research and interpretation content for the exhibits to enable the exhibition and public programme to take place

Party B will:

- a) Produce a contract with Party A for signing by September 2016 for delivery of the Project
- b) Be responsible for identifying suitable accommodation and appropriate subsistence for Party A's staff and guest speakers
- c) Co-develop the Project's public programme


Party C will:

- a) Work to deliver sponsorship for elements of the Project and its related programme, through cash contribution or defrayed costs for elements of the Project and its related programme, which may include sponsorship for a catalogue
- b) Co-develop the Project's public programme
- c) Align in-kind resources to the Project, which may include: postgraduate placements; translation support and conceptual exhibition design support
- d) Host a satellite exhibition or programme at Nottingham Lakeside Arts

Implementation details of particular collaborative agreements shall be negotiated amongst the above organisations as specific cases arise. Such agreements will be legitimised by the completion of a specific collaboration agreement.

The purpose of this Memorandum of understanding is to express the intentions of the Parties and is not intended to be legally binding on any Party.

This Memorandum applies to the University of Nottingham's campuses in the United Kingdom, China and Malaysia, and is subject to revision, renewal or cancellation by mutual consent, effective from completion of signature until the end of the exhibition.


