Re: S31 Grant Determination Letter for the 30 hours free Childcare Early Implementer Innovator Grant in 2015-16. [DfE Ref: CSDSD65/2015] [DCLG Ref: 31/2749]

This Determination is made between:

- (1) The Secretary of State for Education and
- (2) The local authorities listed at Annex A

Background

From September 2017 the government will deliver on its commitment to double the amount of free childcare available to the working parents of three-and four-year-olds. In advance of full implementation, the government is providing early implementer innovator grant funding (for the period of April 2016 - August 2017) to some local authorities during early implementation to create, test and share innovative models for delivering this extended entitlement which will amount to 30 hours free childcare.

In order for parents to access high-quality childcare provision which meets their needs, the Department would like local authorities to focus this grant on the following priorities: flexibility, sufficiency, SEND and work incentives. Examples of possible activity include:

- Engaging and/or working with parents, providers and VCS partners to develop and test different approaches to delivering the extended entitlement
- Exploring ways to grow the market including encouraging providers to build partnerships with each other
- Providing quantitative and qualitative data to the Department about the sufficiency challenges in their area Exploring non-funded options to support families with children who have special educational needs
- Becoming a regional champion and gathering information/ learning from other LAs in the region
- Working with the Department to disseminate learning in preparation for early and national roll-out.

Grant allocations

Total funding of £4 million is available for this programme in 2015-16. Funds will be made available in the form of a non-ring fenced grant.

Local authorities may wish to consider maximising value for money by pooling funding to coordinate regional activity.

The details of allocations to be made to each local authority are set out in **Annex A**.

Payment arrangements

Payment will be made in one instalment in March 2016.

Arrangements for keeping in touch with the Department for Education

The Department for Education will ask local authorities to provide a 6 monthly update in preparation for roll-out of the 30 hours free childcare entitlement.

The Department for Education would also be happy to receive any information about effective practice, approaches and activities LAs develop on early implementation innovation.

This letter has been copied to the Early Years officials and Director of Children's Services from the local authorities listed at **Annex A** and to Her Majesty's Treasury and Department for Communities and Local Government.

Purpose of the grant

2. The purpose of the grant is to provide support to local authorities towards expenditure lawfully incurred or to be incurred by them for early implementer innovator activities.

Determination

3. The Minister of State for Education determines as the authorities to which grant is to be paid and the amount of grant to be paid, the authorities and the amounts set out in Annex A.

Payment arrangements

4. The grant will be paid in one instalment to local authorities set out in Annex A on, or by, 31 March 2016.
