Subject:	Network Circuits Upgrade
Total Value:	£110,590 (Type: Capital and Revenue)
Decision Being Taken:	1) To upgrade a number of network circuits as detailed on the attached schedule. The additional costs for these upgrades over the remaining 4.5 years of the existing contract are £110590 to be funded from the IT Service Improvement Plan.
	2) In accordance with Financial Regulations 3.29, to dispense with the provisions of Contract Procurement Rule 5.1.1 and to award the upgrade directly with our incumbent supplier, Virgin Media Business LTD.

Reasons for the Decision(s)	The Council needs to upgrade a number of circuits to ensure that there is sufficient capacity to support multi - agency and small Nottingham City Council sites . If we do not increase the capacity of these circuits this could result in system issues i.e. freezing or slow running or no accessibility to these sites. In addition increasing these circuits will support the move to Office 365 and enable the Council to fully exploit the newly upgraded Windows Service estate. The Council has an existing contract with Virgin Media Business LTD ("VMB") for the installation of all its data circuits (Executive Board decision 17 March 2015). The contract commenced on 31 October 2015 with the term being 3+1+1, and
	therefore there is a maximum period of 4.5 years remaining. The decision is to add the upgrade of these circuits to this contract. Given that the proposed service is an upgrade of existing circuits installed by VMB for which the Council pays an annual rental, the upgrade can only be undertaken by VMB.
	The additional costs for the upgrades over the remaining 4.5 years of the existing contract are to be funded from the IT Service Improvement Plan. The connectivity review in 3 years time may enable us to move this commitment to the base budget as part of this wider review.

Finance Advice:	This decision requests dispensation from Financial Regulation in order to award the required contract to the incumbent supplier. The financial implication of the decision is £0.111m to be funded from the IT Service Improvement Plan / Windows Server 2003/2008 over four years. As per Exec Board report 24 Feb 2015 £2.0m had been allocated for this project of which £1.052 has been allocated for 2016-17. There is currently £0.455m remaining from the budget allocation for 2016-17, therefore sufficient funds are available to allow this expenditure.

Procurement Advice:	The Council proposes to vary the existing contract with VMB to upgrade the existing circuits and as such requires a dispensation from financial regulations to allow this variation of the original contract. Procurement supports this proposal as the variation complies with the Procurement Regulations and as such there are no significant concerns with this proposal. IT Advice:	The IT Service supports this proposal. Additional capacity is required to support the Council's increasing use of 'cloud' and other Internet based services such as 'software as a service'. The Council's recent acquisition of new licensing for Microsoft licences will enable it to use Office-365, a cloud based office automation application suite, is an example of this. Cloud based managed services provide an up to date and maintained platform for the Council but demand increased Internet connectivity. This proposal addresses this need.
