Decision Being Taken:

- 1) To approve the receipt of grant funding from Coca-Cola Parklives
- 2) To grant delegated authority to Director of Sports & Culture, in consultation with Portfolio Holder for Leisure & Culture, to confirm the Programme and enter into contracts with Coca-Cola Parklives and Local Sports providers to deliver the programme as detailed in Appendix 1 over a 4 year Programme
- 3) To amend the Medium Term Financial Plan to reflect the funding and indicative expenditure as detailed in Appendix 2(exempt) (Portfolio Holder Decision)
- 4) To extend the existing Fixed Term Programme Managers Post for a further four year fixed term (Non-Executive Officer Decision)

Reasons for the Decision(s)

The project has been designed to help activate the community and help provide a sustainable range of opportunities to help improve health and wellbeing. This will support the Council's priorities relating to health and leisure. The activities will help to increase park

usage and help to build pride and ownership which in turn will help tackle and reduce any perceptions of vandalism, crime and antisocial

behaviour within the parks.

Finance Advice:

In March 2015, the Executive Board approved the National Programme of Physical Activity in Parks and Open Green Spaces, which approved the grant receipt and activities for 2 years to March 2017. The funding from the Significant Partner is now available for a further 4 years, and a contract is being prepared confirming the funding and details of the activities in this programme.

Total expenditure during financial years 2017/18 to 2020/21 will be £0.424m - the amount to be spent each financial year will be subject to the activities programme being finalised. The expenditure will be resourced as follows:

£0.394m Parklives Funding Partner

£0.030m Council in kind match funding (Sport & Leisure Project Co-ordination)

The Head of Parks, Open Spaces and Investment Funding will need to ensure the appropriate processes continue to remain in place to meet the conditions of the Significant Partner providing the ParkLives funding as outlined in the contract.

This funding is time limited and should only incur one-off expenditure to match to one-off activities. In the event on-going commitments are accrued, the Head of Parks, Open Space and Investment Funding will need to secure continuation funding or make provision to pay any exit costs.
