Decision Being Taken:	To approve further expenditure of £103,000.00 on the new build development at Cranwell Road, Strelley, and to include this within the Public Sector Housing Capital Programme.
Reasons for the Decision(s)	Additional funding is required due to post contract specification changes in the construction of 48 new homes at the Cranwell Road site.
Other Options Considered:	Not increasing the budget or non-payment - this option was rejected as it would put the Council in breach of contract. Furthermore, the contractor would be at liberty to charge a punitive interest rate for late payment.
