External Legal Expenditure for a Public Hearing
Up to £150,000 (Type: Revenue)
1) To appoint a Queens Counsel to represent the City Council at the Independent Inquiry into Child Sexual Abuse (IICSA) and to provide ancillary advice;
2) To approve the dispensation in accordance with Financial Regulation 3.29 to contract procedure rule 5.1.2, requiring the seeking of competitive tenders.

Reasons for the Decision(s)	The Council is a Core Participant in the Independent Inquiry into Child Sexual Abuse (IICSA).
	IICSA is holding a Public Inquiry into the extent of any institutional failures to protect children in the care of Nottingham City and Nottinghamshire Councils from sexual abuse and exploitation. The public hearing will last for a total of 3 weeks in October 2018.
	IICSA is a high profile Public Inquiry. A report of its findings will be published in 2019.
	A number of current and former Council employees have provided witness statements to the Inquiry and will be called to give live evidence. Evidence will be heard from the Portfolio Holder for Children's Services and the Corporate Director for Children and Adults. Thousands of pages of documents will be considered.
	In light of the significance of the Public Inquiry, it is necessary to appoint an experienced barrister at the level of Queens Counsel to advise and represent the Council. This is in line with the approach taken by other key participants in the Inquiry.
	The decision on who to appoint to have conduct of this matter on behalf of the Council has been considered by the Corporate Director for Children and Adults, and having considered the alternatives, it has been decided that Steven Ford QC of 7 Bedford Row chambers should be appointed to represent the Council at the hearing and to advise the Council on matters relating to IICSA.
	Mr Ford is being proposed due to his specialist knowledge of and experience of the relevant law, procedure and subject matter. He has represented public bodies including Rochdale Council during their strands of the IICSA public inquiry. There are few barristers (if any) who would have a similar level of knowledge of IICSA.
	Furthermore, Mr Ford has had previous dealings with the Council on related matters. He has supported the Council in preparing its Corporate statement which was submitted to the Inquiry in July 2018. As he has a background in the subject matter, he will require less preparation time compared to other barristers with no relevant knowledge, thereby saving costs.
	Subject to receiving approval, we have tentatively agreed a reduced hourly rate for his services. We also intend to save further costs by only requiring his attendance on the days when relevant evidence is being heard during the inquiry or when specific advice is needed. Otherwise, advice and representation will be provided by internal resources (Legal Services).
Other Options Considered:	To use internal resources. There is no internal resource with the level of experience and expertise of a Queens Counsel. Use of other external legal advisers or Counsel would not be appropriate, as they do not have the relevant background, experience and specialist expertise of Steven Ford QC. Therefore this option was rejected.
