Proposed changes to the arrangements for admission to schools in the 2020/21 school year from those determined for the 2019/20 school year. The proposed changes are to amend oversubscription criteria 2 and 4 to give clarity as to when a child is considered to have a sibling at the school concerned; and to amend the definition of siblings to include a stepbrother or stepsister where two children are related by a parent's civil partnership as well as by a parent's marriage.

How different groups could be affected

(Summary of impacts)

1. The proposal to give clarity as to when a child is considered to have a sibling at the school concerned will not affect different groups, as the wording is being changed to give clarity only.
2. The proposal is to change the policy to expand the definition of siblings to include a stepbrother or stepsister where two children are related by a parent's civil partnership as well as by a parent's marriage. The present policy does not include children related by a parent's civil partnership, so the change in policy will benefit those parents who are in a civil partnership and are applying for a school place for their children where they have siblings related by a parent's civil partnership.
