Thank you for your authority's continued work to provide core support for refuges and other accommodation based services and the local reforms needed to meet the Priorities for Domestic Abuse Services. I am pleased to inform you that the Department is now able to issue a Determination covering the 2018-19 element of the 2018/20 fund for domestic abuse services, including refuge, to help local areas meet the priorities for domestic abuse services.
