This report does not raise any significant legal issues and the dispensation can be supported. The value is significantly below the financial threshold which applies to the award of contracts for concession services - currently £4,551,413. There is an argument that this is not a concession caught by The Concession Contracts Regulations 2016 and is a property licence only giving permission to carry out a commercial activity but that does not affect this decision. Finance Advice:

This decision seeks approval to extend the catering concession at Wollaton Park for a further 2 years. The expected income is included in the medium term financial plan (MTFP), and therefore failure to secure this income would lead to an overspend position. Dispensation from contract procedure rule 5.1.2 in accordance with financial regulation 3.29 is supported in order to ensure the income continues as currently expected in the MTFP.
